A former licensee of KMAS-LP filed a Certification of Eligibility with the Commission on or before January 28, 2000, stating that KMAS-LP satisfied all of the requirements for Class A status. A copy of that certification is attached hereto.

On June 9, 2000, however, the Commission issued a Public Notice dismissing KMAS-LP's Certification of Eligibility on the grounds that KMAS-LP was a translator station rather than a low power television station. The station's former licensee petitioned the Commission for reconsideration of that decision, because KMAS-LP's prior filings and the Commission's own records indicated that KMAS-LP was authorized as a low power television station.

Telemundo of Steamboat Springs Colorado License Corporation ("Telemundo") is confident that the Commission will grant the Petition for Reconsideration and accept KMAS-LP's Certification of Eligibility. To date, however, the Commission has not yet acted on the Petition for Reconsideration. In light of the impending deadline for filing Class A applications, Telemundo concluded that it would prudent to submit the instant application now. Consequently, Telemundo hereby requests that the Commission withhold processing of the instant application until it acts on the Petition for Reconsideration.


