

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CC LICENSES, LLC

This statement was prepared on behalf of CC Licenses, LLC ("CCLLC"), a licensee subsidiary of Clear Channel Communications, Inc. ("CCC"). CCLLC proposes to modify the facility of WRNX(FM), Amherst, Massachusetts. This multiple ownership analysis was prepared considering radio stations under present or proposed common ownership, time brokerage or joint sales.

Arbitron Geographic Market Study

The WRNX(FM) community of license, Amherst, Massachusetts, is geographically located in Hampshire County, which is part of the Springfield, MA Arbitron Metro. Moreover, BIA lists WRNX(FM) as "Home" to the Springfield, MA Arbitron Metro. The number of stations owned by CCC in the Springfield, MA Arbitron Metro is not increasing by this proposed modification

According to the FCC's local ownership "tiers," in a Arbitron Metro reported by BIA as having 30 to 44 commercial and noncommercial educational full-power radio stations, a party may have a cognizable interest in up to 7 commercial full-power radio stations, not more than 4 of which are in the same service (AM or FM). This application complies with the multiple ownership rules because only 4 of 30 full-power radio stations (3 FM and 1 AM) in this Arbitron Metro are attributable to CCC. ¹
