TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Quantum of Brunswick License Company, LLC ("Quantum"), proposed assignee of radio stations WYNR, Channel 273C1, and WWSN, Channel 277C, Waycross, Georgia¹; WMOG, 1490 kHz, and WGIG, 1440 kHz, Brunswick, Georgia; WHFX, Channel 224A, St. Simons Island, Georgia; and WBGA, Channel 299C2, Darien, Georgia. The 3.16 mV/m contours of all four FM stations overlap with each other and with the 5.0 mV/m contours of both AM stations. This results in Quantum having interests in four FM stations and two AM stations in the same radio market. Exhibit #1 is a map depicting the stations.

2. Therefore, a study has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. The city grade contours of the subject stations will be used to define the market boundary, hereinafter referred to as the "Radio Market". The study will determine the number of other commercial AM and FM stations that either have transmitter sites within or provide coverage to the subject radio market.²


1) There is an outstanding construction permit for WWSN, which is considered in this instant review.

2) The city grade contour of the licensed WWSN was used to define a portion of the boundary. Since the outstanding permit for WWSN extends farther, the number of stations in the radio market would not decrease if the permit is implemented and, as such, the market would remain in compliance.

3. Exhibit #2 is a depiction of the stations in the Radio Market and shows the transmitter sites or city grade contours of eighteen commercial AM and FM stations, including the six subject stations. Exhibit #3 is a tabulation of the stations in the Radio Market. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.³ At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Qantum's interests in four FM stations and two AM stations in the same market are in compliance with the Commission's rules. Therefore, Qantum's proposed ownership of WYNR, WWSN, WMOG, WGIG, WHFX and WBGA is in compliance with §73.3555 of the rules.

All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the CDBS database. 3) Although there are additional stations providing service to the Radio Market, they are not considered since the number of stations was ample to demonstrate compliance with the rules based on the number of stations proposed to be commonly owned.


