

**EXPLANATION OF APPLICATION**

Prior to July 1, 1994, the legal and beneficial interests in the stock of South Jersey Radio, Inc. were owned by two men: Howard L. Green and Donald M. Simmons, Sr. (each was a 50% shareholder). Under a "Voting Trust Agreement" dated May 9, 1994 (which became effective on July 1, 1994 subsequent to FCC consent), all issued and outstanding shares of South Jersey Radio, Inc. were placed in a "voting trust", in which Howard L. Green was the sole trustee, and, as a result, Mr. Green controlled 100% of the votes represented by the issued and outstanding shares of stock of South Jersey Radio, Inc. The "Voting Trust Agreement" did not affect the beneficial ownership of South Jersey Radio, Inc., in that Mr. Green and Mr. Simmons each continued to own 50% of the equity interests of South Jersey Radio, Inc.

An application on FCC Form 316 was filed on May 25, 1994 seeking FCC consent to the changes to South Jersey Radio, Inc.'s corporate structure represented by the "Voting Trust Agreement". File Numbers BTCCT-940525KN through BTCTVL-940525KT were assigned to this application (the "Voting Trust Agreement" is on file as a part of that application), and the application was granted on June 14, 1994.

Pursuant to Paragraph 13(b)(i) of the Voting Trust Agreement, "This Agreement will be terminated by the first to occur of the following: (i) the death or disability of the Trustee . . .". Howard L. Green died on September 29, 2002. A copy of a certificate of the Atlantic County, New Jersey Surrogate's Court showing the date of death and also showing that Mary Jane B. Green and Donald J. Green are the Executors of Mr. Green's estate. Mary Jane B. Green, of Linwood, New Jersey, is the widow of Howard L. Green, and Donald J. Green, of Cherry Hill, New Jersey, is a brother of Howard L. Green.

In the aftermath of the termination of the Voting Trust Agreement, the legal and beneficial ownership of South Jersey Radio, Inc. is as follows: 75 shares, or 50% of the issued and outstanding shares, are owned by the Estate of Howard L. Green, Mary Jane B. Green and Donald J. Green, Executors; and the other 75 shares, or 50% of the issued and outstanding shares, are owned by the Estate of Donald M. Simmons, Deceased, by Jeffrey McEwen (of Sayre, Pennsylvania) and Donald M. Simmons, Jr. (of Athens, Pennsylvania) as Co-Administrators.

Calvin Green and Donald J. Green are the brothers of Howard L. Green.

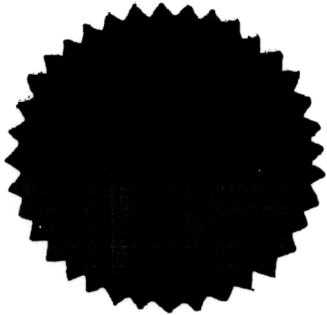
