A TRANSMITTER FAILURE DAMAGED ONE LEG OF THE DIPLEXER PRIOR TO RUNNING A PROOF ON IT; IN ADDITION, COVID-19 ADVERSELY AFFECTED THE LICENSEE'S ABILITY TO FIND TECHNICAL PERSONNEL TO PERFORM REPAIRS AND TAKE MEASUREMENTS. ALTHOUGH WELM IS NOW ABLE TO MEET ITS LICENSED PARAMETERS, ISSUES REMAIN WITH THE ABILITY OF THE DIPLEXED STATION, WEHH, TO OPERATE WITHIN ITS LICENSED PARAMETERS. DUE TO THESE ISSUES, IT IS REQUESTED THAT AUTHORITY TO OPERATE AT VARIANCE DURING THE NIGHTTIME HOURS BE CONTINUED SO THAT THE APPLICANT CAN RESOLVE THESE ISSUES PERMANENTLY.
