BHC also holds various translator, booster and auxiliary authorizations.

BHC is a nonprofit corporation under Section 501(c)(3) of the Internal Revenue Code and is controlled by The First Presidency (“First Presidency”) of The Church of Jesus Christ of Latter-day Saints (the “Church”), which consists of each succeeding President of the Church and counselors appointed by the President. The President of the Church is Thomas S. Monson. The Board of Directors (Trustees) of BHC is appointed (and subject to removal) by the First Presidency.

The First Presidency also controls the DMC Reserve Trust, which is the sole shareholder of Deseret Management Corporation (“DMC”), a Utah corporation. DMC is the sole shareholder of Deseret News Publishing Company, a Utah corporation and publisher of the Deseret News, a daily newspaper published in Salt Lake City, Utah.

DMC is also the sole shareholder of Bonneville International Corporation (“BIC”), a Utah corporation. Pursuant to an Amended and Restated License Agreement, a copy of which is on file with the Commission, BIC manages and operates the stations licensed to BHC.

The Church controls Brigham Young University, Provo, Utah, the licensee of noncommercial educational stations KBYU-FM, Provo, Utah (FIN 6825) and KBYU-TV, Provo, Utah (FIN 6823), and the permittee of a new noncommercial educational radio station on Channel 210A, Clarkston, Utah (FIN 174114). The Church also controls Brigham Young University – Idaho, the licensee of noncommercial educational radio stations KBYI(FM), Rexburg, Idaho (FIN 56345) and KBYR-FM, Rexburg, Idaho (FIN 56352), and the permittee of a new noncommercial educational radio station on Channel 210C1 at Afton, Wyoming (FIN 173939).
