Dear Licensee:

Golden Corners Broadcasting, Inc. ("Golden") is hereby notified of the modification of license (BLH-20060525ACD) for WCCP-FM, Clemson, South Carolina to specify Channel 288A.

On August 7, 2012, Clear Channel Broadcasting Licensees, Inc. ("Clear Channel"), licensee of Station WROO(FM), Mauldin, SC, filed a minor change application (BPH-20120807ACG)<sup>1</sup> proposing the substitution of Channel 288A for Channel 285A at Clemson, SC and the modification of the above captioned license.<sup>2</sup> Section 316(a) of the Communications Act of 1934, as amended, permits us to modify the license or construction permit if such action is in the public interest. The Act requires that we notify the affected station of the proposed action, the public interest reasons for the action, and afford at least 30 days to respond. Accordingly, by staff letter dated October 24, 2012, Golden was directed to show cause why its license should not be modified to specify Channel 288A in lieu of Channel 285A. As of this date, Golden has not responded to the October 24, 2012 staff letter, and thus, has consented to the channel substitution.

<sup>2</sup> The license of FM Station WCCP-FM at Clemson, SC can be modified to specify operation on Channel 288A in lieu of Channel 285A at the station's current authorized transmitter site (BLH-20060525ACD). The authorized coordinates for the license at Clemson, SC, are 34° 38' 13" N.L., 82° 42' 30" W.L.

Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, That effective the date of this letter, the FM assignment IS MODIFIED as follows:

Add 288A, Delete 285A

Pursuant to Section 316(a) of the Communications Act of 1934, as amended, license BLH-20060525ACD IS MODIFIED to specify operation on Channel 288A in lieu of Channel 285A.

Within 30 days of the effective date of this letter, Golden shall submit to the Commission a minor change application for construction permit (Form 301). Upon grant of the construction permit, program tests may be conducted in accordance with Section 73.1620 of the Commission's Rules. Nothing contained herein shall be construed to authorize a change in transmitter location or to avoid the necessity of filing an environmental assessment pursuant to Section 1.1307 of the Commission's Rules.
