REPLY COMMENTS

On March 28, 2005, E-String Wireless, LTD. filed a counterproposal in this proceeding proposing to relocate the reference coordinates of the proposed new allocation for Mt. Enterprise, Texas, Channel 231A, in order to accommodate a change in transmitter site for its new Lufkin station. As stated by E-String Wireless, this change in transmitter site is necessary to optimize coverage of the Lufkin-Nacogdoches market. As further stated by E-String Wireless, the proposed new reference coordinates for Channel 231A at Mt. Enterprise<sup>1</sup> would be fully spaced to all other stations and allotments and that city-grade service would be provided to the community of Mr. Enterprise.


