

***\*This minor amendment to WPAY-FM Application BPH-20070119ACD proposes a fully spaced Special Reference Point for Sect. 73.215 purposes toward contingent WJZK(FM) application BPH-20070119ACO, which is being simultaneously amended. The WJZK(FM) application is being amended to replace the formerly requested community of Grandview Heights, OH, with the new community of West Jefferson, OH, and increase the antenna COR to 100 meters HAAT. This amended WPAY-FM Class C0 downgrade and the WJZK amendment are both proposing simultaneous §73.215 processing against each other, therefore, fully spaced reference points have been supplied in each amended application. These two contingent applications are to be processed, pursuant to Section 73.3517(e) of the Rules, with one other contingent application(s): (1) WQEL(FM), facility ID #7112, Bucyrus, OH, which is filing an application to change its community of license to Richwood, OH, to replace service that would be lost by the relocation of WJZK(FM), facility ID #30563, Richwood, OH, to West Jefferson, OH. These applications are filed as part of a related group of applications to make changes in facilities, and cross-references each of the related applications. This application includes a copy of the agreement to undertake the coordinated facility modifications between the licensee of WJZK(FM) and WQEL(FM) and the licensee of WPAY-FM.***




