OTHER AUTHORIZATIONS

The proposed assignee, Multimedia Holdings Corporation ("Multimedia Holdings"), is licensee of broadcast television stations KARE(TV), Minneapolis, Minnesota; KNAZ-TV, Flagstaff, Arizona; KPNX(TV), Phoenix, Arizona; KUSA-TV, Denver, Colorado; and WTLV(TV), Jacksonville, Florida. Multimedia Holdings is a wholly-owned subsidiary of Multimedia, Inc. ("Multimedia") which in turn is a wholly-owned subsidiary of Gannett Co., Inc. ("Gannett"). The following description reflects the attributable interests of the parties to this application in broadcast licensees.

Attributable Interests in Other Broadcast Stations

Gannett, a Delaware corporation, is the parent company of thirteen (13) Commission licensees, which collectively hold licenses for 21 television stations. Gannett has its corporate headquarters at 7950 Jones Branch Drive, McLean, Virginia. The company is also a major owner of daily newspapers in the United States and United Kingdom, and is the holder of other business interests.

The list below reflects the call signs for the Gannett-controlled broadcast stations, their cities of license, corporate licensees of the respective stations, and the Gannett subsidiaries which control the licensees. All subsidiaries are 100%-controlled by Gannett. It should be noted that several of the officers and directors of Multimedia Holdings, listed on Exhibit A of this FCC Form 314, also hold similar positions in one or more of the licensees listed below, as more specifically set forth in the ownership reports on file for those licensees.
