Mountain Wireless, Inc. complies with the local radio ownership rules set forth in 47 C.F.R. section 73.3555 (a)(1) (iii). In a radio market with between 15 and 29 (inclusive) full-power, commercial and noncommercial radio stations, not more than 6 commercial radio stations in total and not more than 4 commercial stations in the same service (AM or FM) can be owned by the same licensee.

Mountain Wireless, Inc. is the licensee holder of 2 full-power commercial FM radio stations, WCTB (Fairfield, ME, Fac. ID 46353), WFMX (Skowhegan, ME, Fac. ID: 26388) and 1 full-power commercial AM radio stations, WSKW (Skowhegan, ME, Fac. ID: 46351). Since Mountain Wireless, Inc. is the licensee of only 3 full-power commercial radio stations they comply with the local radio ownership rules set forth in 47 C.F.R. section 73.3555 (a)(1) (iii).
