Dear Counsel:

The staff has under consideration the Petition for Reconsideration filed May 6, 2009, on behalf of Mt. Wilson FM Broadcasters, Inc. ("MWFB"). MWFB seeks reconsideration of the staff's April 7, 2009, denial of its April 6, 2009, request for special temporary authority ("STA") to increase the power of the KKGO digital signal by 27 percent. MWFB now seeks a very brief test, of three days' duration, in order to assess the potential coverage and interference effects of the proposed digital power increase. MWFB states that it believes the test will demonstrate that it will not have to purchase new or upgrade its existing equipment, in the event the Commission acts favorably on the proposed digital power increase currently under consideration in MM Docket No. 99-325. MWFB further states that budget planning, particularly in a "down" economy, is a significant factor for any broadcast licensee.

On reconsideration, we find that the brief test now proposed by MWFB is not likely to result in interference to other stations and that it will provide information useful to MWFB in its budget planning process.

Accordingly, the Petition for Reconsideration IS GRANTED, and the request for STA, as modified by the Petition, IS GRANTED. Station KKGO may operate with a hybrid digital signal at variance from the specifications in the *First Report and Order* in MM Docket No. 99-325. In particular, authority is granted for operation with increased digital effective radiated power, not to exceed 1.27 percent of the licensed analog effective radiated power. Operation pursuant to this authority is limited to a total of three consecutive business days, prior to the expiration date

below. Operation pursuant to this authority must be discontinued if complaints of interference are received, unless such complaints are immediately resolved by other technical means.

This authority expires on **August 29, 2009**. No extension of this authority is contemplated.
