Additionally, the three general partners of Americom CA, (1) A. Thomas Quinn, an individual, (2) R.N. Inc., a Nevada corporation, and (3) City News Service Inc., a California corporation, each seek FCC approval for the following transactions: A. Thomas Quinn seeks to transfer his interests in Americom CA, City News Service, Inc. and Radio

Partners to A. Thomas Quinn, Trustee of the A. Thomas Quinn Revocable Trust; R. N. Inc. has changed its name to R.N. Nevada Inc.; and City News Service, Inc. proposes to change its state of incorporation by merging with and into City News Service, Inc., a Nevada corporation.
