MINOR AMENDMENT: VOLUNTARY TIME SHARE AGREEMENT

The parties in the caption, by their attorney, here request the normal processing and grant of the attached minor amendment, consisting of a voluntary time share among them. The applicants were identified as tied and in first place with other applicants in Group No. 27, in the public notice released on July 9, 2014, FCC 14-96A2. This agreement is timely submitted within the 90-day widow provided by Public Notice, FCC 14-96A1, p. 6.

The attached agreement is in writing and is in full compliance with the requirements of Section

73.872(c) of the Commission's Rules and Regulations: (i) The agreement specifies the proposed hours of operation for each time share proponent. (ii) The proposal does not provide for any simultaneous operations. (iii) Each proponent proposes to operate for a minimum of 10 hours per week. Here in fact, the full 168-hour week is divided among the proponents.

Each of the parties to this agreement was tentatively awarded five points, the most points of any group member. This included a point for the affirmative representation in Section III, Question 2: “The applicant pledges to originate locally at least eight hours of programming per day.” In any multi-party time share beyond three, the hours in the day are maxed out and this becomes impossible. The Commission anticipated this at the very inception of the point system, in its Report and Order, *Creation of a Low Power Radio Service*, 15 FCC Rcd. 2205 (rel. on January 27, 2000). The order stated: “Time sharers may aggregate points under each of the three selection criteria.” Id. Para. 147. This was explained there in Id., fn. 240:

For example, two time-sharers that claimed points individually for established community presence and proposed operating hours and local program origination may claim a combined two points for each of these criteria for a total of six points. *They need not aggregate hours of operation or locally-originated programming to aggregate their points for these criteria.*

Emphasis supplied. The point tallies have undergone minor changes since 2000 but the basic policy remains. Here the individual time sharers are entitled to aggregate their points, even though not required to aggregate their hours. They share credit for the promised eight total hours of locally originated programming, one to or from another.

The Commission's policy make equitable sense because the parties are doing as much as they possibly can, here with the maximum, around-the-clock 168-hour broadcast service per week. The scoring also seems right, because the goals of localism and diversity are well served by the time share, and every member's positive role in it. In the greater Los Angeles market, the number of applicants bespeaks overwhelming unsatisfied demand for new local noncommercial radio service. A large time share such as the one we have here takes a few steps – more are needed – toward satisfying these needs in diverse ways. For these reasons, the Commission here must confirm what it said in 2000 and fully

credit the five points awarded to each time-share participant here, then aggregating them under established rules and policies.

For the foregoing reasons it is requested that the attached time share be approved.






