Dear Counsel:

This is in reference to the request filed January 12, 2007, on behalf of AMFM Radio Licenses, LLC ("AMFM"). AMFM requests extension of the special temporary authority ("STA") originally granted on July 14, 2006, and modified on September 19, 2006, to operate Station WWRC with parameters at variance and/or reduced power while maintaining monitor points within licensed limits.¹ In support of the request, AMFM states that station's facilities were damaged by a tenant, that it has initiated eviction proceedings against the tenant and that the proceedings are ongoing. AMFM states that the tenant's continued presence has hampered its repair efforts.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

¹ WWRC is licensed for operation on 1260 kHz with 5 kilowatts daytime and 5 kilowatts nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U).

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WWRC may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. AMFM must notify the Commission when licensed operation is restored.² AMFM must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **March 11, 2008**.
