**General**

The instant application proposes a first local service for Hometown, Indiana, and an improved technical facility for WQHK-FM. WADM(AM) will remain as a local service at Decatur. In accordance with established precedent, removing a community's second local service and leaving it with a daytime only station is justified by providing a first local service at another community. (See *Ravenswood and Elizabeth, WV*, Report and Order, 10 FCC Rcd 3181 (MMB 1995) and *Chillicothe, Dublin, Hillsboro, and Marion, Ohio*, Memorandum Opinion and Order, MM Docket 02-226 (July 7, 2006).)



The entire gain and loss area associated with the instant proposal will remain well-served by at least five aural services. See attached map and tabulation of stations.




