




**CHANGES IN INTERESTS**

For business reasons, Clear Channel Communications, Inc. (“Clear Channel”) proposes the *pro forma* assignment of certain licenses held by AMFM Radio Licenses, LLC to AMFM Broadcasting Licenses, LLC. Figure 1 attached shows the current ownership structure: AMFM Radio Licenses, LLC is a wholly owned subsidiary of AMFM Broadcasting, Inc. As depicted in Figure 2 attached, Clear Channel proposes to assign the licenses to another wholly owned subsidiary of AMFM Broadcasting, Inc, AMFM Broadcasting Licenses, LLC. Because all of the entities involved in this proposed transaction are ultimately controlled by Clear Channel, the use of Form 316 is appropriate. Because this proposed transaction involves an internal restructuring, there are no agreements.

Lists of the officers, directors and shareholders of each of the relevant Clear Channel companies are attached hereto.

(note 1) Clear Channel Communications, Inc. is a publicly traded company with the majority of its shares owned by the investing public, i.e., parties other than officers, directors and affiliates. With the exception of L. Lowry Mays (see note 2), no single stockholder owns as much as 5% of Clear Channel Communications, Inc.'s stock.

(note 2) The 5.2% voting and equity ownership percentage of Clear Channel Communications, Inc. stock that is attributable to L. Lowry Mays includes the stock held by various trusts, annuities, and options over which Mr. L. Mays has either sole or shared investment authority.

(note 3) Various financial institutions hold, in the aggregate, debt interests equaling approximately 35% of the combined assets of all stations whose licenses are held by subsidiaries of Clear Channel Communications, Inc.
