

**EXHIBIT 10 – CHANGES IN INTEREST**

Currently, the licensee is Weigel Broadcasting Company, which is structured as follows:

Howard Shapiro:	Chairman, Director, and 48 percent voting shareholder
Norman Shapiro:	President, Secretary, Treasurer, Director, and 17 percent voting shareholder
Fred Bishop (as trustee):	29 percent voting shareholder

Upon grant and consummation of this assignment of license application, the licensee will be a limited partnership.

The General Partner of the limited partnership licensee entity will be Madison Halsted LLC, a Limited Liability Corporation which will have a 0.2 percent equity interest in the licensee. Madison Halsted LLC will be structured as follows:

Howard Shapiro:	Chairman, Director and 48 percent voting member

Fred Bishop (as trustee):	29 percent voting member
