RE: Local Marketing Agreement

Dear Mr. Field:

Reference is made to the Local Marketing Agreement (the "LMA") dated as of October 31, 2006 among Entercom Cincinnati, LLC ("Entercom") and Susquehanna Radio Corp. and WVAE Lico, Inc. (collectively, "Susquehanna"). Pursuant to the LMA, Entercom and Susquehanna have agreed that Entercom will broker substantially all of the air time on the Exchange Party Station as defined in the LMA (the "Station"), on the terms and conditions contained therein.

Section 10.8 of the LMA provides, with certain exceptions, that no assignment by Entercom of its rights under the LMA may be made without Susquehanna's prior written consent, such consent not to be unreasonably withheld or delayed. Susquehanna hereby consents to Entercom's entering into a local marketing agreement or time brokerage agreement with Bonneville International Corporation ("BIC"), pursuant to which Entercom will broker to BIC the airtime on the Station that it brokers from Susquehanna, provided that Susquehanna shall have no obligation or liability to BIC thereunder and nothing herein shall release Entercom from any obligation it has to Susquehanna under the LMA. The consent granted herein is expressly conditioned on BIC's agreement, as evidenced by its signature below, that it will assume, succeed to and perform (and cause its subsidiaries and affiliates to observe and perform) the obligations and rights of Entercom pursuant to the Agreement Ancillary to Sale of Business (the "Ancillary Agreement") in the form attached to the Asset Exchange Agreement dated as of October 31, 2006 between Entercom and Susquehanna, provided that the FCC grants (a) the application for consent to the assignment of the license for the Exchange Party Station (File No. BALH-20061114ACZ), including the amendment thereto filed on February 23, 2007 (the "Amendment"), and (b) the application for assignment of the license for the Exchange Party Station (File No. BALH-20070131AJB), amended to reflect the matters described in the Amendment.
