

Exhibit 16 – Other Media Interests

The proposed assignee, TV-49, Inc. is also the licensee television station WMLW-TV, Racine, Wisconsin (FCC Facility ID No. 68545). TV-49, Inc. was a successful bidder in the Broadcast Television Incentive Auction to relinquish its spectrum usage rights with respect to WMLW-TV. See *Incentive Auction Closing and Channel Reassignment Public Notice*, DA 17-314, Appendix A (April 13, 2017). TV-49, Inc. intends to file an application for construction permit to modify the license of WMLW-TV to specify operations on a shared basis with commonly-owned WBME-CD.
