1. Duff Ackerman & Goodrich QP Fund II, L.P. ("QP Fund") – **86.0297%** (V/E) membership interest in Peak. QP Fund structure is:
 - a. DAG II, LLC¹ ("DAG II") DAG II as the General Partner holds 1% of the equity and votes all 100% of the QP Fund.
 - b. *Limited Partners* – The QP Fund more than 70 limited partners holding 99% of the equity. These Limited Partners are properly insulated under precedent and Rules of the FCC.
2. Duff Ackerman & Goodrich II, L.P. ("DAG II, LP") – **8.1264%** (V/E) membership interest in Peak. DAG II, LP structure is:
 - a. DAG II, LLC DAG II as the General Partner holds 1% of the equity and votes all 100% of DAG II, LLC interests.
 - b. *Limited Partners* – DAG II, L.P. has more than 45 limited partners holding 99% of the equity. These Limited Partners are properly insulated under precedent and Rules of the FCC.
3. DAG GP Fund II, LLC ("DAG GP") – **4.8912%** (V/E) membership interest in Peak. DAG GP ownership structure is:
 - a. John M. Duff, Jr. – Member – 41% (V/E)
 - b. Arnold W. Ackerman – Member – 13% (V/E)
 - c. R. Thomas Goodrich – Member – 41% (V/E)
 - d. John J. Cadeddu – Member – 5% (V/E)
4. DAG II Partners Fund, LLC ("Partners Fund") – **0.9527%** (V/E) membership interest in Peak. Partners Fund² structure is:
 - a. MaCathel, L.P. – Member – 4.1% (V/E)

SUMMARY OF MEMBERSHIP VOTING OF PEAK

DAG II or related DAG entities vote more than 99% of the Equity of Peak Broadcasting, LLC. Specifically:

- 1. DAG II Votes **94.1561%** of all Peak membership interests (QP 86.0297% + DAG II, LP 8.1264%).
- 2. DAG GP members vote **4.8912%** of all Peak membership interests.
- 3. Partners Fund members vote **less than 1%** of the total Peak membership interest.
