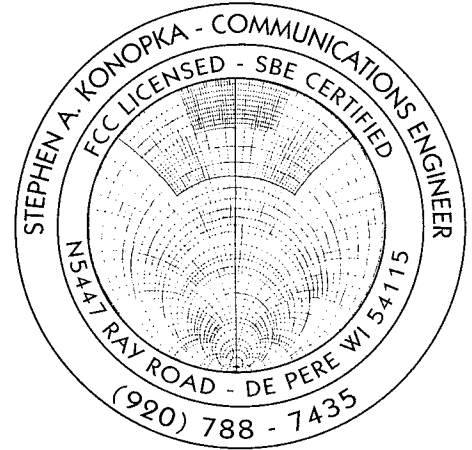



pts 1-5 are nails set with lathe next to them.

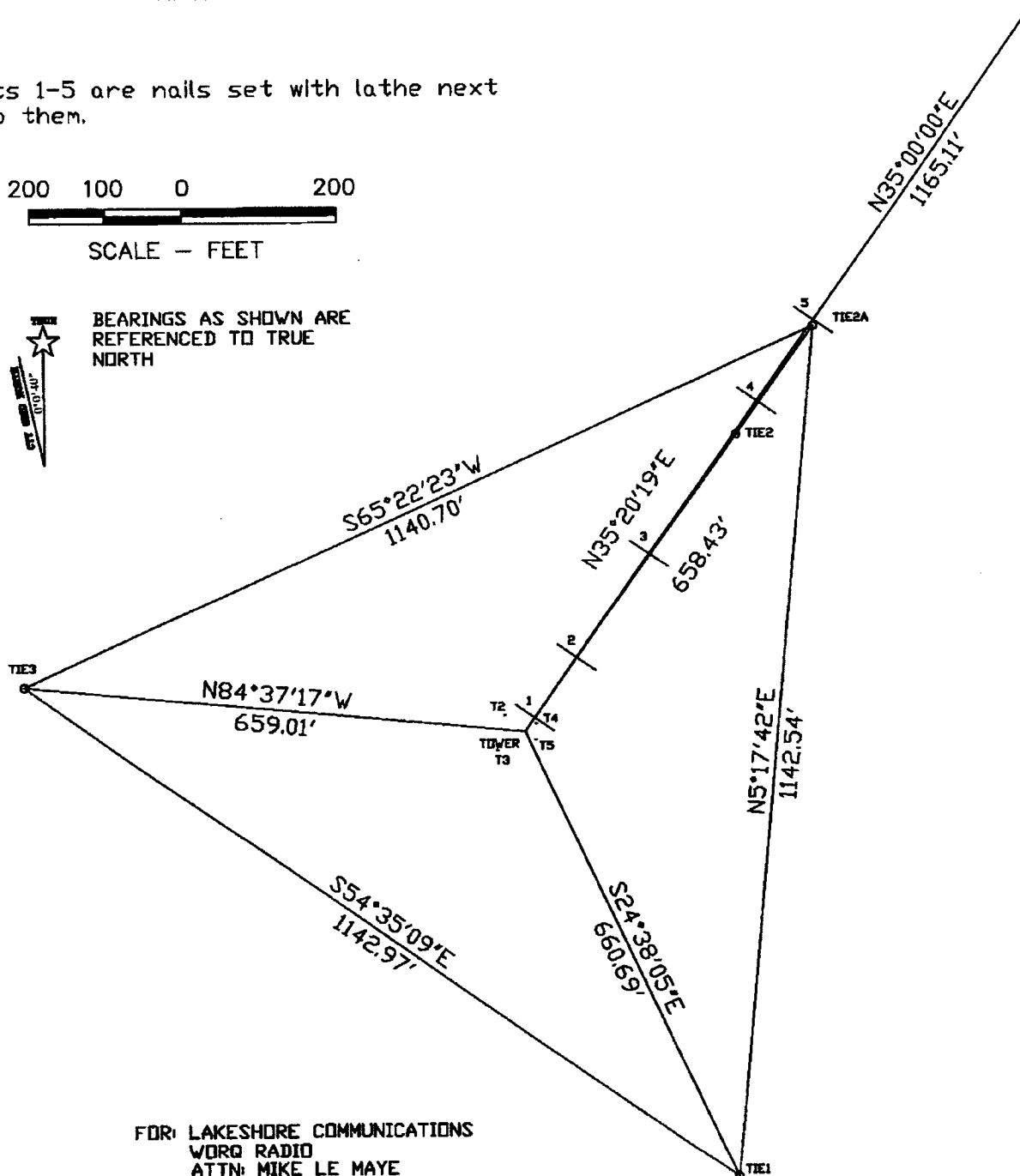
