NEBCO also owns 65% of the shares of Radio Broadcasting Services, Incorporated (“RBSI”). RBSI is the licensee of Stations WWMP(FM), Waterbury, Vermont (FIN: 20592) and WWMP-FM1, Montpelier, Vermont (FIN: 110504), and permittee of Station W251AX, St. Albans, Vermont (FIN: 155550). Mr. Silberberg is Vice President, Secretary and a Director of RBSI. Mr. Flanagan is President, Treasurer, and a Director of RBSI.

NEBCO is the sole member of County Broadcasting Company, LLC, the licensee of Stations WJOE(AM), Orange-Athol, Massachusetts (FIN: 51118), WNYN-FM, Athol, Massachusetts (FIN: 51124), and WGAW(AM), Gardner, Massachusetts (FIN: 72088). Mr. Silberberg is the Manager of County.

Mr. Silberberg owns 89.9% of the shares of Montpelier Broadcasting, Inc. (“MBI”). MBI is the licensee of Stations WNCS(FM), Montpelier, Vermont (FIN: 43655); W262AA, Montpelier, Vermont (FIN: 43656); and WDOT(FM), Danville, Vermont (FIN: 4001). MBI owns all of the shares of Galloway Communications, Inc. (“Galloway”), the licensee of Station WSKI(AM), Montpelier, Vermont (FIN: 23049). Mr. Silberberg is Vice President, Secretary and a Director of MBI and Galloway. Mr. Flanagan is a 10.1% shareholder of MBI and President, Treasurer, and a Director of MBI and Galloway.

NEBCO also owns 100% of the shares of Appaloosa Broadcasting Company, Inc. (“Appaloosa”). Appaloosa is the licensee of Stations KIMX(FM), Laramie Wyoming (FIN: 82007) and KHAT(AM), Laramie, Wyoming (FIN: 10333). It is also the broker of time on

Station KRQU(FM), Laramie, Wyoming (FIN: 9761). Mr. Silberberg is the President, Secretary and a Director of Appaloosa. Mr. Flanagan is the Vice President, Treasurer and a Director of Appaloosa.

Oregon Trail is also the 100% shareholder of Bad Lands Broadcasting Company, Inc. ("Bad Lands"). Bad Lands has received the Commission's consent, in File Nos.
