**DESCRIPTION OF THE TRANSACTION / USE OF FORM 316**

This application seeks FCC consent to the *pro forma* assignment of the license of KSNT, Topeka, Kansas (Facility ID # 67335) from Montecito Television License Corporation of Topeka (“Licensee”) to NVT Topeka Licensee, LLC (“NVTTL”), a newly formed Delaware limited liability company that, through various intervening entities, will be wholly owned and controlled by New Vision Television, LLC (“New Vision”).

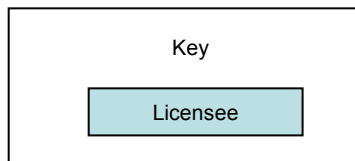
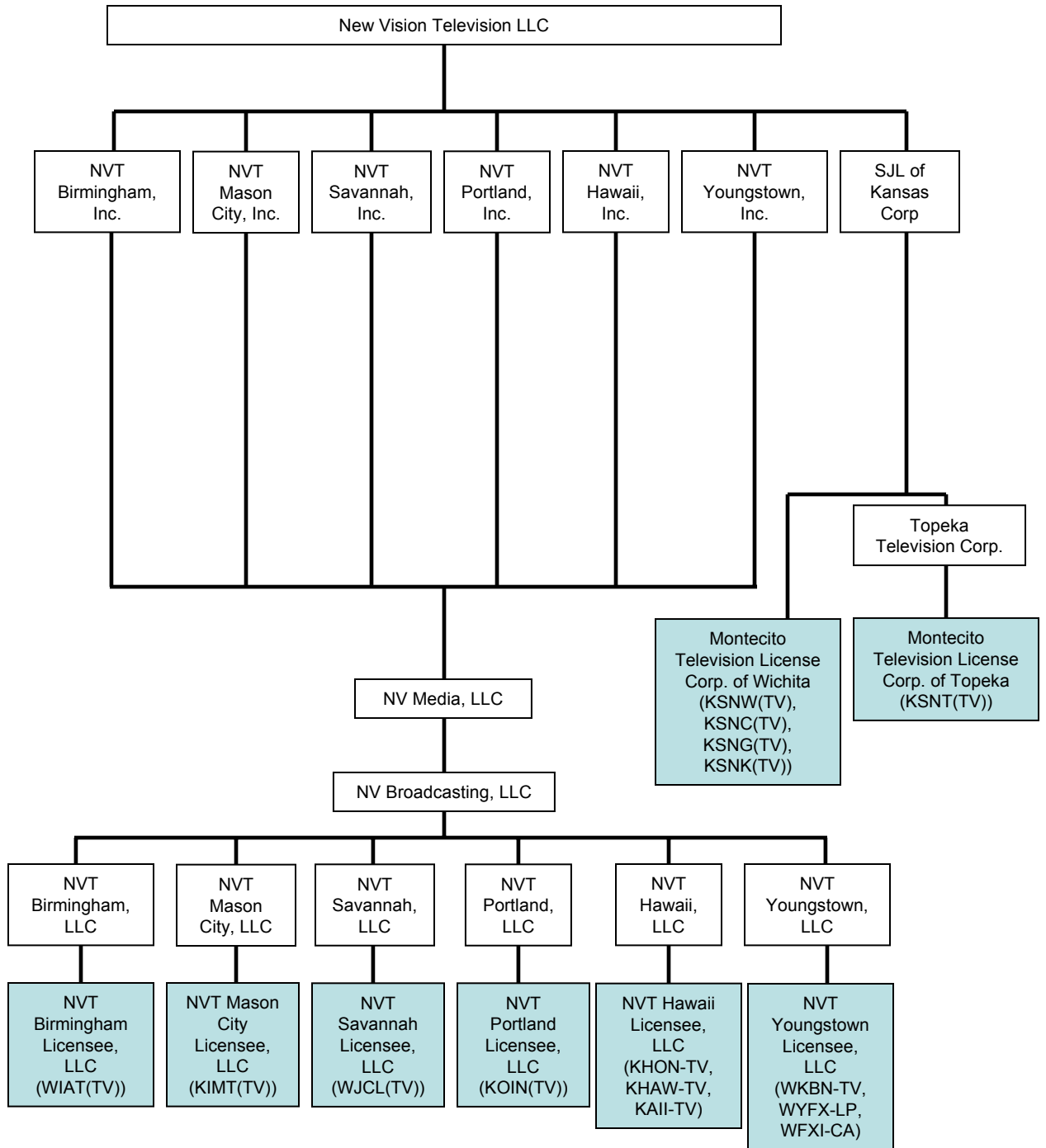


Figure 2: Post-Consummation Structure

On July 30, 2007, Montecito Broadcast Group, LLC and New Vision filed an FCC Form 315 for transfer of control of Licensee to New Vision. *See* FCC File No. -20070730AHM. As reflected in Figure 1, Licensee is proposed to become a wholly owned subsidiary of New Vision. Immediately upon consummation of the transfer of control, New Vision will effect an internal restructuring pursuant to which the KSNT licenses will be assigned from Licensee (at that point controlled by New Vision) to NVTTL. Figure 2 represents the ownership of NVTTL following the consummation of the proposed *pro forma* assignment.

Because both NVTTL and Licensee will be wholly owned subsidiaries of New Vision at the time of consummation, this transaction is *pro forma* and the use of FCC Form 316 is appropriate.

As an internal, *pro forma* assignment, this transaction does not involve documents of the type described in Section II, Item 6 and Section III, Item 4.

**Narrative Description of the Assignee**

The Assignee is NVT Topeka Licensee, LLC (the "Assignee"). The sole member of the Assignee will be NVT Topeka, LLC ("NVTT"). The sole member of NVTT is NV Broadcasting, LLC ("NV Broadcasting"). The sole member of NV Broadcasting is NV Media, LLC ("NV Media"). NVT Youngstown, Inc. ("NVTY Inc."), holding a 10.9% interest in NV Media, NVT Birmingham, Inc. ("NVTB Inc."), holding a 6.3% interest in NV Media, NVT Savannah, Inc. ("NVTs Inc."), holding a 4.1% interest in NV Media, NVT Mason City, Inc. ("NVTMC Inc."), holding a 1.9% interest in NV Media, NVT Portland, Inc. ("NVTP Inc."), holding a 34.5% interest in NV Media, NVT Hawaii, Inc. ("NVTH Inc."), holding a 26.5% interest in NV Media, NVT Wichita, Inc. ("NVTW Inc."), holding a 10.2% interest in NV Media, and NVT Topeka, Inc. ("NVTT Inc."), holding a 5.6% interest in NV Media will be the only members of NV Media and each of these members is wholly-owned by New Vision Television, LLC ("New Vision"), with the exception of NVTW Inc. and NVTT Inc., which are wholly-owned by NVT Kansas, Inc. Jason Elkin, John Heinen, and William Ballard are members of New Vision. Jason Elkin has a 1.9% interest in New Vision, John Heinen has a 0.8% interest, and William Ballard has a 0.3% interest. HBK NV LLC ("HBK NV") is the fourth member of New Vision, with a 97.0% interest in New Vision.

The managing members of HBK NV are Jamiel A. Akhtar, David C. Haley, Richard L. Booth, Laurence H. Lebowitz, and William E. Rose (the "HBK Managers"), each with a 20% voting interest in HBK NV and an equity interest of less than one percent in HBK NV. The other member of HBK NV, which is a non-voting member, is HBK Fund L.P. ("HBK Fund"), a multi-billion dollar diversified private investment fund.

HBK Fund has a sole general partner, HBK Capital L.P. ("HBK Capital"), and more than 100 limited partners with non-attributable interests.<sup>8</sup> HBK Capital has an equity interest

of less than one percent in HBK Fund. The remaining equity interests in HBK Fund are distributed among the limited partners with non-attributable interests.

HBK Capital has a sole general partner, HBK Partners I L.P. ("HBK Partners"), and limited partners with non-attributable interests. The indirect equity interest in the Assignee held by each of HBK Partners and each limited partner of HBK Capital through their respective interests in HBK Capital will represent less than one percent of the Assignee.

HBK Partners has a sole general partner, HBK Management LLC ("HBK Management"), limited partners with non-attributable interests, and certain limited partners identified below that have attributable interests. The non-insulated limited partners of HBK Partners are the HBK Managers, Jeffrey D. Estes and J. Baker Gentry Jr. The indirect equity interest in the Assignee held by each of HBK Management and each limited partner, including each non-insulated limited partner, of HBK Partners through their respective interests in HBK Partners will represent less than one percent of the Assignee.

The HBK Managers are the sole members of HBK Management. Each HBK Manager has a 20% voting interest in HBK Management. The indirect equity interest in the Assignee held by each HBK Manager through their respective interests in HBK Management will represent less than one percent of the Assignee.

Figure 1: Pre-Consummation Structure
