

Schedule 3.4(b)

FCC Matters

- On September 23, 2013, Bright House Networks, LLC filed an informal objection against the license renewal application filed by Hoak Media of Panama City License, LLC, licensee of WMBB(DT), raising arguments based on retransmission consent. This matter remains pending before the FCC.
- On March 15, 2006, the FCC released a NAL in which it found that certain CBS network affiliates aired material that apparently violates the federal restrictions regarding the broadcast of indecent material. The NAL related to the December 31, 2004 “Our Sons and Daughters” episode of “Without A Trace” and found Hoak Media of Colorado LLC, licensee of KREX-TV, Grand Junction, Colorado and Noe Corp. L.L.C., the then-licensee of KNOE-TV, Monroe, Louisiana, apparently liable for a monetary forfeiture in the amount of \$32,500 per station. *In the Matter of Complaints Against Various Television Licensees Concerning Their December 31, 2004 Broadcast of the Program “Without a Trace,”* 21 FCC Rcd 2732 (2006). On May 5, 2006, ninety-five local broadcast television stations affiliated with the CBS television network, including KREX-TV and KNOE-TV, filed with the FCC an Opposition to the NAL and, on June 12, 2006, filed a Motion to Vacate and Supplemental Opposition to the NAL. KREX-TV also filed a supplement to the opposition requesting that the FCC reduce the forfeitures imposed on the stations in the event it does not grant the opposition filed by the ninety-five network affiliates. This matter remains pending before the FCC.

- Hoak Media of Colorado License, LLC initially included a request to renew all of its television translator stations in Exhibit 2 of the application to renew KREX-TV (FCC File No. 20051201BKL). On July 28, 2006, Hoak Media of Colorado License, LLC filed (1) an amendment to the application to renew the KREG-TV station license to include in Section V of the application a request to renew television translator stations K07GD, K06HZ, K13ML, K02HW, and K40CS; (2) an amendment to the application to renew the KREY-TV station license to include in Section V of the application a request to renew television translator stations K02GC, K06GQ, K09MR, K02GJ, K03FX, and K03AY; and (3) a new application to request renewal of K09QA and K44CA.⁷ On March 28, 2007, the FCC granted the application requesting renewal of K09QA and K44CA.
- Hoak Media of Nebraska License, LLC initially included a request to renew all of its television translator stations in Exhibit 2 of the application to renew KHAS-TV (FCC File No. 20060201BJH). On July 28, 2006, Hoak Media of Nebraska License, LLC filed (1) an amendment to the application to renew the KHAS-TV station license to include in Section V of the application a request to renew television translator stations K14IY;⁸ and (2) an amendment to the application to renew the KNOP-TV station license to include in Section V of the application a request to renew television translator stations K35AL, K18DH, K21CY, and K20DK.⁹
- Stations KREX-TV, KREY-TV, and KREG-TV will be filing license renewal applications on or before December 2, 2013. In these applications, each Station will include the following disclosure regarding the timely filing of materials in the Station's public inspection file¹⁰:
 - The Station's annual EEO Public File Report for 2012 was due December 1, 2012 but was not uploaded to the online public inspection file until February 4, 2013. This

report was created and filed in the public inspection file at the Station's main studio on December 1, 2012.

- Station KGJT-LP will be filing a license renewal application on or before December 2, 2013. In this application, KGJT-LP will include the following disclosures regarding the timely filing of materials in, and completeness of, the Station's public inspection file:
 - The Station's EEO Public File Report for 2012 was due December 1, 2012 but was not uploaded to the online public inspection file until April 8, 2013, and the reports for 2008-2011 should have been uploaded to its online public inspection file by February 4, 2013 but were not uploaded to the file until April 17, 2013;
 - The Station should have placed quarterly Class A eligibility certifications in its public inspection file from the start of the license term, but did not begin including these certifications until April 17, 2013; and
 - The Station's Children's Television Programming Report for the third quarter of 2011 was missing from the FCC database for these reports from January 6, 2012 to November 5, 2013. The report was timely filed with the FCC on October 7, 2011 and placed in the public inspection file at the Station's main studio. However, due to administrative error, the report had been inadvertently designated as the report for Q4 2011 rather than Q3 2011 at the time of filing in the FCC database. The Station assumes that when the actual Q4 2011 report was filed the misidentified report for Q3 2011 was automatically replaced and deleted from the FCC database. The report was re-filed when this error was discovered.
- Station KFYR-TV will be filing a license renewal application on or before December 2, 2013. In this application, KFYR-TV will include the following disclosures regarding the timely filing of materials in the Station's public inspection file:
 - The Station's Commercial Limits in Children's Programming Certification for the third quarter of 2012 was due on October 10, 2012 but was not uploaded to the online public inspection file until October 11, 2012; and
 - The Station's Commercial Limits in Children's Programming Certification for the fourth quarter of 2012 was due on January 10, 2013 but was not uploaded to the online public inspection file until January 21, 2013.
- Stations KQCD-TV, KMOT, and KUMV-TV will be filing license renewal applications on or before December 2, 2013. In these applications, each Station will include the following disclosures regarding the timely filing of materials in the Station's public inspection file:
 - The Station's Commercial Limits in Children's Programming Certification for the third quarter of 2012 was due on October 10, 2012 but was not uploaded to the online public inspection file until August 13, 2013;

- The Station's quarterly Commercial Limits in Children's Programming Certifications for Q2 2006-Q2 2012 should have been uploaded to the online public inspection file by February 4, 2013 but were not uploaded to the online file until August 13, 2013. Regarding these certifications and the Q3 2012 certification, the certifications were timely filed in the public file at the Station's main studio. However, in uploading materials to the online public file, the Station inadvertently uploaded the certifications for KFYZ-TV. KQCD-TV, KMOT, and KUMV-TV are satellite stations of KFYZ-TV and broadcast the same children's programming as KFYZ-TV. Accordingly, the certifications that were initially uploaded to the online file for each of these stations before the February 4, 2013 deadline contained information regarding commercial limits in the children's programming identical to that aired on each satellite station. The certifications referencing the correct station were uploaded to the online public inspection file when the error was discovered; and
- The Station's Commercial Limits in Children's Programming Certification for the fourth quarter of 2012 was due on January 10, 2013 but was not uploaded to the online public inspection file until January 21, 2013. The certification was timely created and placed in the public inspection file at the Station's main studio.
- KUMV-TV will include the following disclosure regarding FCC violations during the proceeding license term:
 - On September 12, 2012 Hoak Media Dakota License, LLC ('Hoak Dakota') received a Notice of Violation stating that an agent of the Enforcement Bureau's Denver District Office inspected antenna structure #1050840, which is registered to KUMV-TV, and found that Hoak Dakota was in violation of 47 C.F.R. § 17.50, which requires certain antenna structures to be cleaned and repainted as often as necessary to maintain good visibility, because paint on the antenna structure was faded and chipped. By letter dated August 13, 2013, Hoak Dakota informed the Enforcement Bureau that the antenna had been repainted. No further action has been taken by the Commission.
- Stations KSFY-TV, KPRY-TV, and KABY-TV will be filing license renewal applications on or before December 2, 2013. In this application, each Station will include the following disclosures regarding the timely filing of materials in the Station's public inspection file:
 - The Station's Commercial Limits in Children's Programming Certification for the third quarter of 2012 was due on October 10, 2012 but was not uploaded to the online public inspection file until December 20, 2012. The certification was timely created and placed in the public inspection file at the Station's main studio; and
 - The Station's quarterly Commercial Limits in Children's Programming Certifications for 2007 should have been uploaded to the online public inspection file by February 4, 2013 but were not uploaded to the online file until November 14, 2013. The certifications were timely created and placed in the public inspection file at the Station's main studio.

- Station KVLV-TV will be filing a license renewal application on or before December 2, 2013. In this application, KVLV-TV will include the following disclosures regarding the timely filing of materials in the Station's public inspection file:
 - The Station's Children's Television Programming Report for the first quarter of 2009 was missing from the FCC database for these reports from July 9, 2009 to November 7, 2013. The report was timely filed with the Commission on April 10, 2009 and placed in the public inspection file at the Station's main studio. However, due to administrative error, the Q2 2009 report was marked as Q1 2009 at the time of electronic filing in the FCC database. Because of this, the Station assumes the FCC filing system deleted the previously filed Q1 report, replacing it with the Q2 report. Upon discovery of this issue, the Station immediately re-filed the correct report for Q1 2009 in the FCC database;
 - The Station's Commercial Limits in Children's Programming Certification for the third quarter of 2012 was due on October 10, 2012 but was not uploaded to the online public inspection file until October 11, 2012;
 - The Station's Commercial Limits in Children's Programming Certification for the fourth quarter of 2012 was due on January 10, 2013 but was not uploaded to the online public inspection file until January 11, 2013;
 - The Station's Issues and Programming Report for the third quarter of 2012 was due October 10, 2012, but was not uploaded to the online public inspection file until November 19, 2012. The report was timely created and placed in the public inspection file at the Station's main studio;
 - The Station's retransmission consent elections should have been uploaded to the online public inspection file by February 4, 2013, but two of these elections were not uploaded to the file until September 17, 2013. The elections were timely placed in the public inspection file at the Station's main studio;
 - The Station's EEO Public File Report for 2012 was due December 1, 2012 but was not uploaded to the online public inspection file until February 4, 2013. The Report was timely created and placed in the public inspection file at the Station's main studio; and
 - The Station's EEO Public File Report for 2007 should have been uploaded to the online public inspection file by February 4, 2013 but was not uploaded to the file until September 13, 2013. The Report was timely created and placed the public inspection file at the Station's main studio.
