TGI owns 100% of the issued and outstanding common stock of Telemundo of Chicago, Inc. (“Telemundo-Chicago”). Telemundo-Chicago in turn owns 100% of the issued and outstanding common stock of Video 44 Acquisition Corp., Inc. (“Video Acquisition”). Video Acquisition has a 50% general partnership interest and Telemundo-Chicago has a 24.5% general partnership interest in Video 44, licensee of Television Station WSNS-TV, Chicago, Illinois. (Facility ID No. 70119)

TGI owns 100% of the issued and outstanding stock of Telemundo of Key West, Inc. which provides more than 15% of the weekly programming to Television Station WEYS(TV) pursuant to a Local Marketing Agreement dated as of June 1, 2001 with WEYS Television Corp.

Certain of the directors and shareholders of Telemundo have ownership interests in other media properties as described below.

2.) Madison Dearborn Partners

Certain managing directors of Madison Dearborn Partners, LLC (“MDP”) hold an attributable interest in WBEE(AM), Harvey, Illinois (Facility ID No. 40147).

3.) Council Tree Communications

Council Tree Communications VI, L.P., which is owned by several of the same investors as Council Tree Hispanic Broadcasters II, L.L.C. (“CTHB”), filed an application with the FCC to acquire Television Station KMAZ(TV), Las Cruces, New Mexico (Facility ID No. 36916), and Television Translator K46DH, Las Cruces, New Mexico (Facility ID No. 36919) on February 8, 2001.

Arctic Slope Regional Corporation, Stephen C. Hillard, President and Chief Executive Officer of CTHB and certain of the Managing Directors of MDP hold membership interests in Council Tree Communications III, L.L.C., which holds a controlling interest in Hispanic Broadcasters of Philadelphia, L.L.C., permittee of WWSI(TV), Atlantic City, New Jersey (Facility ID No. 23142).

The officers, directors, and shareholders of Arctic Slope Regional Corporation, Stephen C. Hillard, and certain Managing Directors of MDP also hold a membership interest in Council Tree Communications V, L.L.C., licensee of KXRE(AM), Manitou Springs, CO (Facility ID No. 54258), and KAVA(AM), Pueblo, CO (Facility ID No. 54259).

5.) Liberty

Liberty Digital, Inc. (“Liberty Digital”), a subsidiary of Liberty Media Corporation,⁹ holds a 10 percent interest in MTVi Group, Inc. (“MTVi”), which controls a number of low power television (“LPTV”) licenses. However, Liberty’s indirect ownership interest in the above LPTV stations is not attributable. A division of Viacom International Inc. is the single majority shareholder in MTVi, holding a 90 percent interest. In any event, the Commission expressly declined to apply the multiple ownership and cable cross-ownership restrictions to LPTV service. See An Inquiry into the Future Role of Low Power Television Broadcasting and Television Translators in the National Telecommunications System, 51 R.R.2d 476, at ¶¶ 83-95(1982).

Liberty also holds a non-attributable interest in USA Networks, which has an ownership interest in a number of full-power television stations. The Commission has previously determined, however, that Liberty’s interest in USA Networks is not pertinent with respect to the ownership of the Telemundo stations. See Letter to Tom W. Davidson, Esq., from Barbara Kreisman, Esq., Chief, Video Services Division (July 30, 1998) (FCC File Nos. BTCCT-971230PA-QC). To the extent that AT&T Corp. may be deemed a party to this application, AT&T also may have indirect ownership interests in certain LPTV stations. However, any such interests do not implicate multiple ownership and cable cross-ownership concerns. On November 15, 2000, AT&T announced that its Board of Directors had voted to split-off Liberty Media Group as an independent, publicly-traded company. The split-off is expected to be consummated on August 10, 2001.

Liberty holds a minority interest (approximately 13 percent) in Emmis Communications Corp. (“Emmis”). Emmis owns multiple radio and television station licensees in the United States. Liberty’s interest in Emmis is non-attributable because Emmis’ Chairman of the Board, President and Chief Executive Officer, Jeffrey H. Smulyan, holds more than 50 percent of the combined voting power of Emmis’ common stock.

Finally, Liberty also holds non-attributable minority interests in Time Warner, Inc. (“TWI”) and The News Corporation Limited (“News”), each of which holds indirect ownership interests in one or more television stations.

To the best of Telemundo’s knowledge, no other parties hold attributable interests in other broadcast stations.
