Mr. Reyner is also President, a manager and 36 percent owner of Mission TV, LLC, which controls KEVN, Inc., the licensee of KEVN-TV, Rapid City, South Dakota (Facility ID No. 34347), and KIVV-TV, Lead, South Dakota (Facility ID No. 34348). Additionally, Mr. Reyner is the sole trustee of the William S. Reyner Trust and the Charles S. Reyner Trust, each of which is a member of Mission TV, LLC. Mr. Reyner is also President and a Director of KEVN, Inc.
