OWNERSHIP STRUCTURE

ICA Broadcasting I, Ltd. (“ICA Ltd.”) is a Texas Limited partnership. The sole general partner of ICA Ltd. is ICA Broadcasting, L.L.C. (“ICA LLC”), a Texas limited liability company. Both ICA Ltd. and ICA LLC have their Principal place of business at 700 North Grant Street, Suite 600, Odessa, Texas 79761. Under the terms of ICA Ltd.’s limited partnership agreement, the general partner has 100% control of the day-to-day operations of the partnership.¹

The remaining limited partnership interests are held by: 1) John C. Nichols and Barry Marks; and 2) a number of investment trusts established for the benefit of the children and/or grandchildren of John Bushman and Ed Lasater. All of the individual partners in the partnerships and beneficiaries of the trust are U.S. citizens. None of the partnership or trusts hold greater than a 7.98% equity interest in ICA Ltd. and none holds an attributable interest in the licensee as defined by the commission’s Rules.²
