FM BROADCAST STATION CONSTRUCTION PERMIT

Subject to the provisions of the Communications Act of 1934, subsequent Acts, and Treaties, and Commission Rules made thereunder, and further subject to conditions set forth in this permit, ^{1/} authority is hereby granted to

CARROLL COUNTY BROADCASTING CORPORATION
to construct an FM broadcast station located and described as follows:

1. Station location: State Maryland City Westminster
2. Transmitter location: State Maryland County Carroll
City or Town Westminster
Street and number Clarke Road, 0.2 miles south of Uniontown Road
North Latitude: Degrees 39 Minutes 24 Seconds 37
West Longitude: Degrees 77 Minutes 01 Seconds 21
3. Main studio location: State Maryland County Carroll
City or Town Westminster
Street and number Clarke Road, 0.2 miles south of Uniontown Road
4. Description of transmitter:

Gates, Type No. FM-1B, rated power 1 kw.

5. Description of antenna system:

Andrew, Type No. 1306-2, 6 sections.
FM antenna to be side-mounted at top of existing antenna tower of WTR(AM).
Overall height above ground: 203 feet.
Obstruction marking specifications in accordance with paragraphs 1, 3, 12 and 21 of FCC Form 715, attached.
Subject to WTR receiving permission from the Commission to determine power of WTR by the indirect method during installation of the FM antenna and checking resistance of the tower after the installation has been completed; any change in resistance will necessitate submission of Forms 302 for WTR.

6. Operating assignment:
 - (a) Frequency 100.7 Megacycles.
 - (b) Transmitter output power 1 ~~kilo~~ **watt**.
 - (c) Effective radiated power 4.6 ~~kilo~~ **watts**.
 - (d) Antenna height above average terrain 190 feet.
 - (e) Hours of operation - Unlimited
7. Date of required commencement of construction 7-6-59
8. Date of required completion of construction 1-6-60
9. Equipment and program tests shall be conducted only pursuant to Sections 3.216 and 3.217 of the Commission Rules.
10. This permit shall be automatically forfeited if the station is not ready for operation within the time specified or within such further time as the Commission may allow unless completion of the station is prevented by causes not under the control of the permittee. See Section 1.314 of the Commission Rules.
