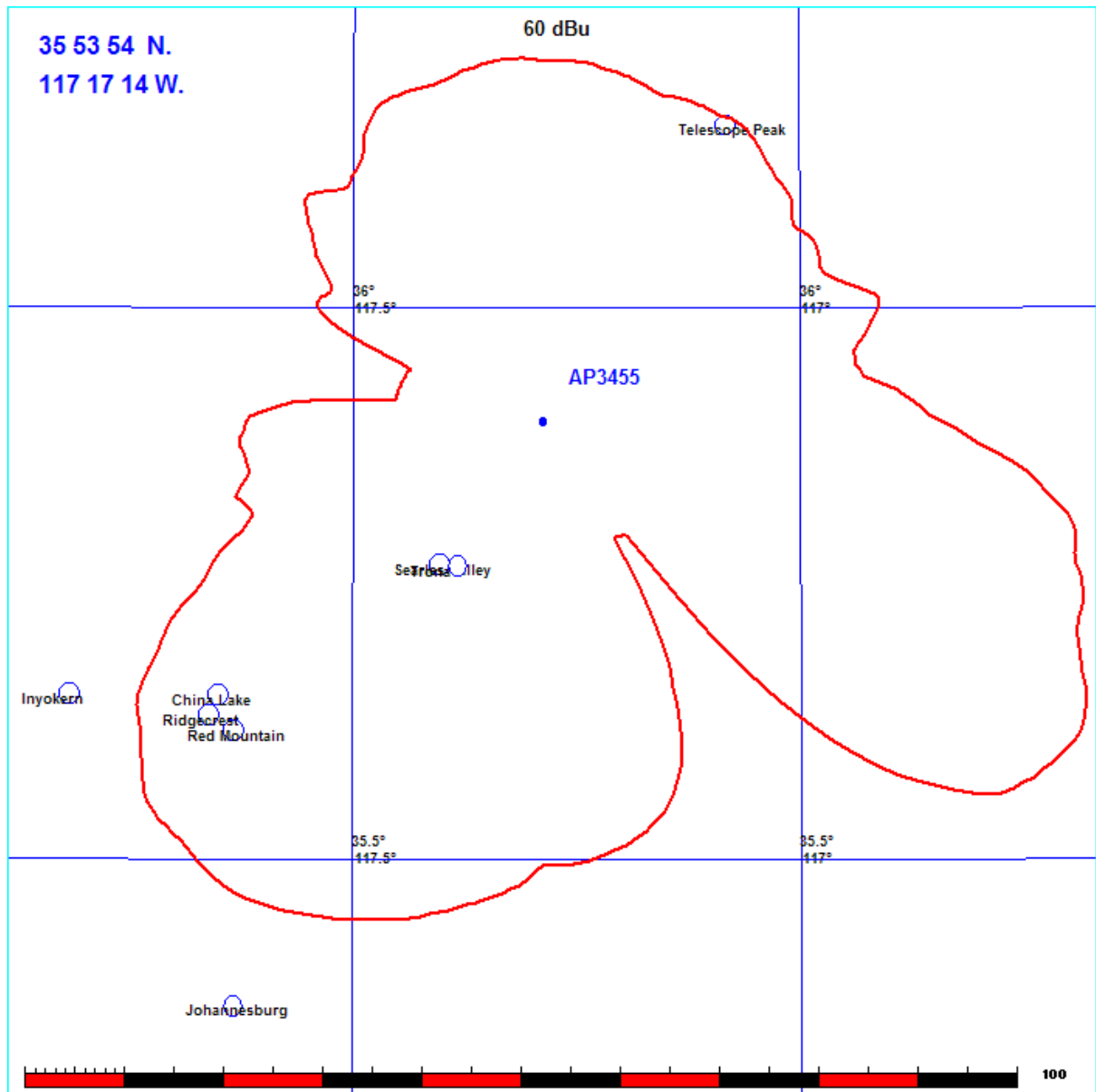

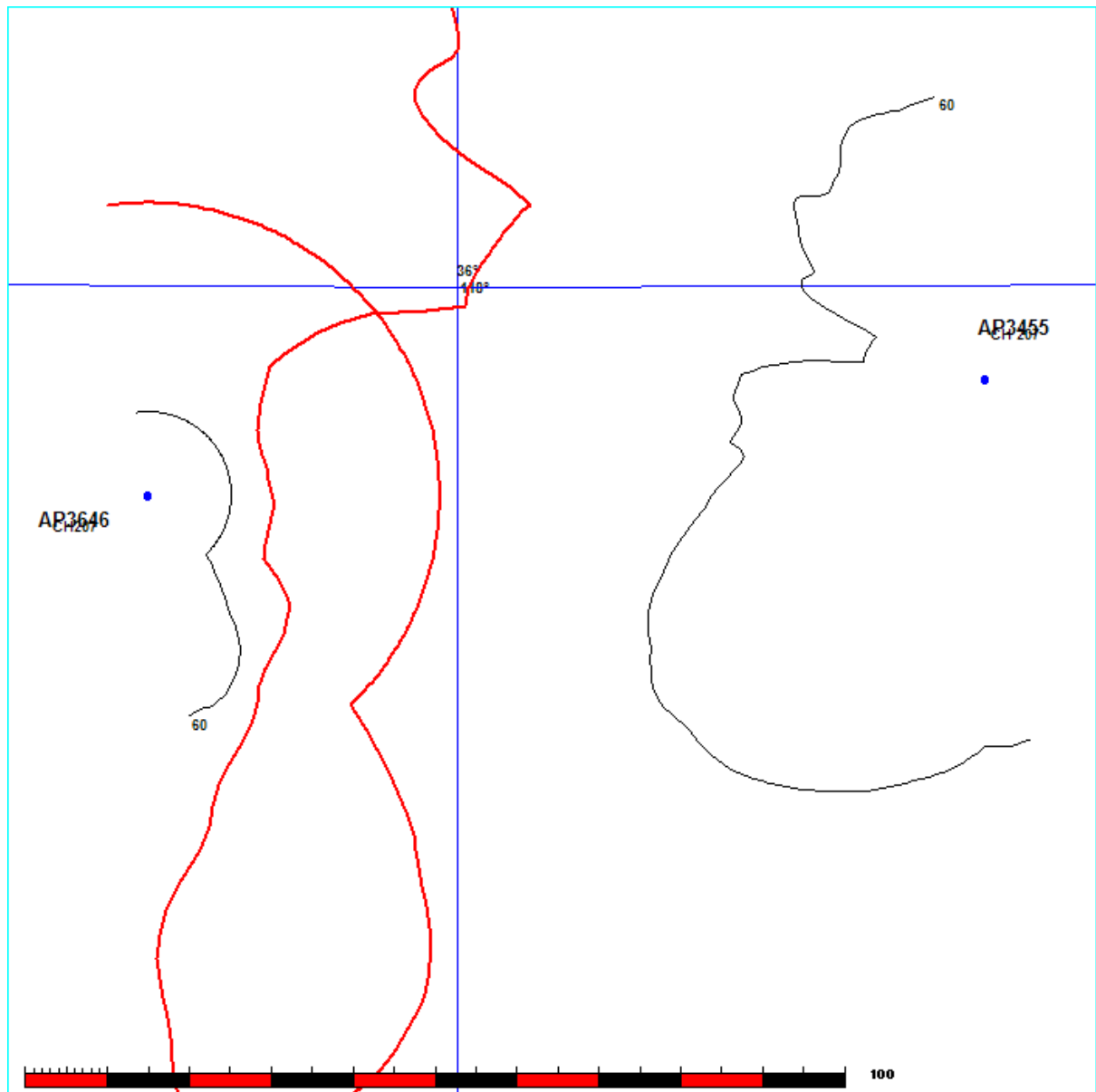

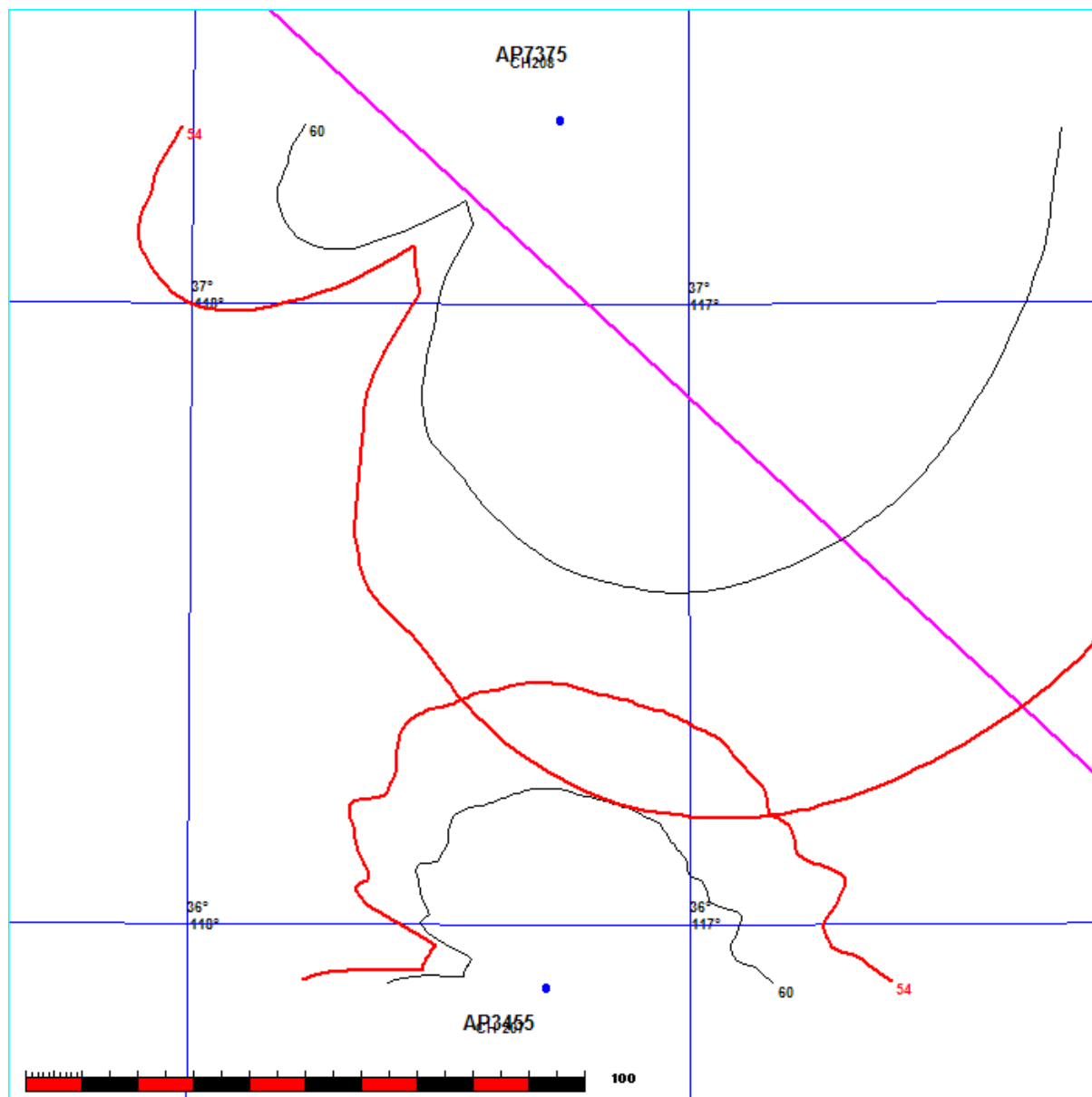
Proposed new 60 dBu contour covers proposed city of license, Ridgecrest, CA



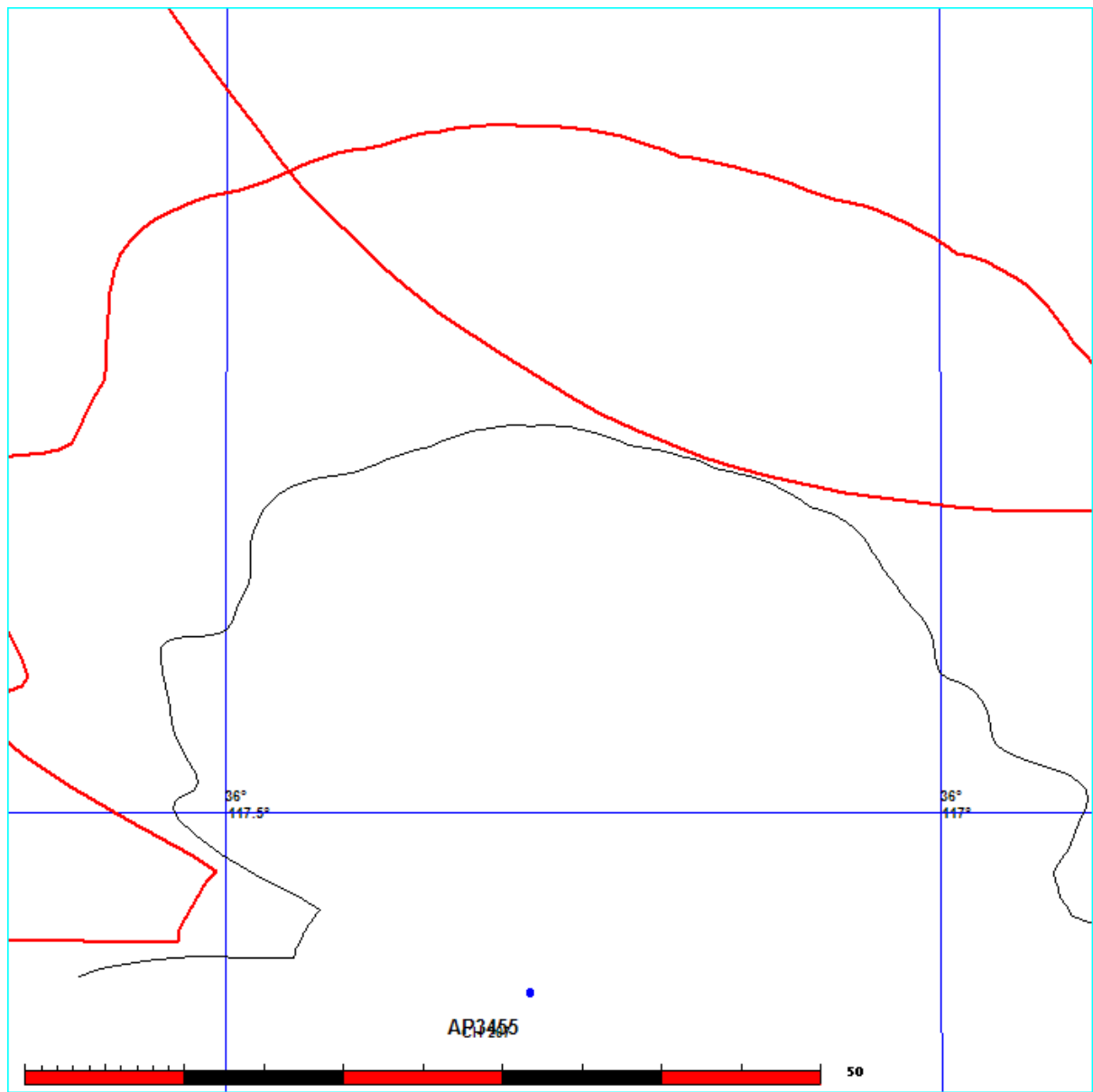
