** LIN TV Corp ("Company") has two classes of voting stock. Class C common stock represents 70% of the Company's voting power and Class A common stock represents the remaining 30% voting power. Both classes generally vote together as a single class on all matters submitted to a vote of the Company stockholders. Mr. Fojtasek and Mr. Carson, through intermediaries, each holds Class C common stock representing 35% of the Company's total voting power. The Class A common stock is publicly traded, with no Class A holder having 5% or more of the Company's total voting power. Class B nonvoting common stock is held by Hicks Muse Tate and Furst and its affiliates. Class B stockholders lack voting rights but, without the consent of at least a majority of Class B stockholders, the Company may not enter into certain significant transactions.
