

INTERFERENCE ANALYSIS  
TELEVISION STATION WEDW-DT  
BRIDGEPORT, CONNECTICUT  
CHANNEL 49

It is proposed that WEDW-DT make an early transition to its post-transition digital facility on Channel 49. WEDW-DT holds a construction permit for post-transition operation on Channel 49 with a maximum directional ERP of 41 kW and an antenna height of 222 m HAAT (See FCC File No. BPEDT-20080207AAV).

An interference analysis was conducted for the proposed operation of WEDW-DT on Channel 49 pursuant to the parameters authorized in BPEDT-20080207AAV. This study was conducted pursuant to procedures of FCC Office of Engineering and Technology Bulletin No. 69 (OET-69). This study considered all analog or digital full-service and Class A television stations that could be affected within the normal OET-69 inclusion distances. The results of this study are included herewith. Only the worst-case scenarios with respect to each station studied are listed in the interference analysis report.

The results of this analysis indicate that any predicted interference caused by the WEDW-DT operation on Channel 49 to any analog or digital full-service stations or Class A television stations will be well within the FCC's 2%/10% de minimis

interference criteria. Therefore, the early transition of WEDW-DT on Channel 49 will have no adverse interference impact on any other analog or digital full service or Class A television station.
