

Pro Forma Transfer of Control

This application seeks consent to the *pro forma* transfer of control of the license currently held by KYTX License Company, LLC (“KYTX”), which is wholly owned by London Broadcasting Company, Inc. (“London”). As the result of an internal restructuring, the direct ownership interests in London held by certain of its limited partners, SunTx Capital Partners II, L.P., SunTx Capital Partners II Dutch Investors, L.P. and Thrivent White Rose Fund, will simply now be held through a new limited partnership, SunTx LBC Holdings, L.P. There are no other changes to London’s ownership structure. Because ultimate control of the license that is the subject of this application does not change, the transfer of control proposed herein is *pro forma* in nature, and use of FCC Form 316 is appropriate. More specific information pertaining to those parties with attributable interests in KYTX and London, including SunTx LBC Holdings, L.P., follows.
