

Exhibit 5 – Compliance with Local Radio Ownership Rule

Ramar Communications II, Ltd. (“Ramar”) is the licensee of KSTQ-FM, Plainview, Texas. For purposes of the local radio ownership rule, KSTQ-FM is deemed to be a part of the Lubbock, Texas Arbitron Metro. KXTQ-FM is licensed to Plainview, Hale County, Texas, which is located outside the Lubbock, Texas Metro, as defined by Arbitron. However, BIA Research, Inc. reports KSTQ-FM as being home to the Lubbock, Texas Metro.

The attached exhibit was compiled on May 21, 2007 using BIA Research, Inc.’s *Media Access Pro* database. The exhibit lists all radio stations, including KSTQ-FM, that are licensed to communities within the counties comprising the Lubbock, Texas Metro or that Arbitron designates as “home” to that Metro. As demonstrated in the exhibit, there are 27 operating stations and one construction permit for a new, unconstructed AM station in the Lubbock, Texas Metro, as so defined. Under the local radio ownership rule, a person or single entity (or entities under common control) in a radio market with between 15 and 29 (inclusive) full-power, commercial and noncommercial radio stations may have a cognizable interest in up to 6 commercial radio stations (not more than 4 of which are in the same service (AM or FM)).

As shown in the exhibit, Ramar controls 4 radio stations that are either located in or considered home to the Lubbock, Texas Metro (1 AM and 3 FM), including KSTQ-FM, which fully complies with the local radio ownership rule.

Because the communities of license of two of the four stations owned by Ramar are located outside of the Lubbock, Texas Metro (KLZK(FM), Brownfield, Texas, and

KSTQ-FM, Plainview, Texas), a showing of compliance using the interim contour-overlap methodology also is attached. That showing indicates that the contours of 11 AM stations and 21 FM stations overlap the radio market defined by the overlapping contours of the four radio stations owned by Ramar. A person or single entity (or entities under common control) in a radio market with between 30 and 44 (inclusive) full-power, commercial and noncommercial radio stations may have a cognizable interest in up to 7 commercial radio stations (not more than 4 of which are in the same service (AM or FM)). Ramar's ownership of the 1 AM and 3 FM stations identified herein fully complies with the local radio ownership rule as determined by the interim contour-overlap methodology as well.
