

**CHANGE IN INTERESTS**

The instant application seeks Commission consent to the pro forma transfer of control of Wilks License Company-Fresno LLC from Wilks Broadcast Group Holdings LLC (the “Transferor”), a direct subsidiary of Wicks Radio Group LLC, to Wilks Broadcast Group II Holdings LLC (the “Transferee”), a new direct subsidiary of Wicks Radio Group LLC. The Transferee will be the managing member of the Transferor. The member structure will be the same for both the Transferor and the Transferee. As there will be no beneficial change in ownership and control of the stations, the transaction is pro forma in nature. A chart reflecting the “Before” and “After” structures of the companies involved in this transaction is attached for the Commission’s convenience.

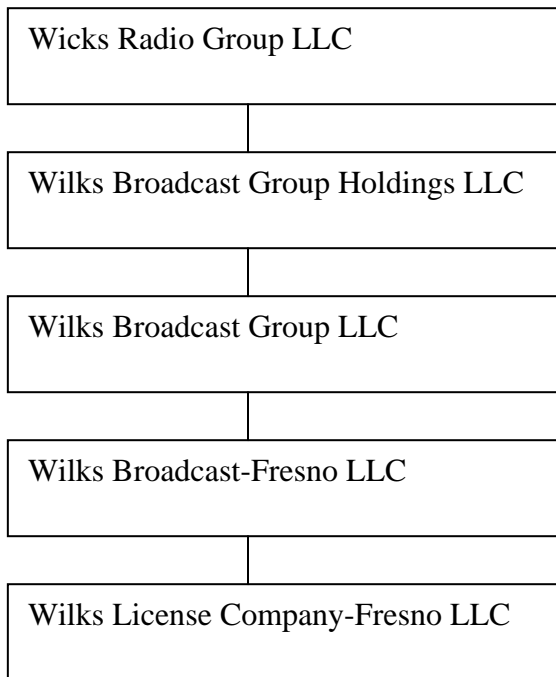
To be more specific, at the current time, prior to the consummation of the proposed pro forma transfer of control, Wilks License Company-Fresno LLC, is controlled by Wilks Broadcast-Fresno LLC which, in turn, is controlled by Wilks Broadcast Group LLC which, in turn, is controlled by Wilks Broadcast Group Holdings LLC which, in turn, is controlled by Wicks Radio Group LLC which, in turn, is controlled by Wicks Communications & Media Partners III, L.P., which, in turn, is controlled by its sole general partner, Wicks Capital Management III, L.P. which, in turn, is controlled by its sole general partner, Wicks Apex III, Inc. which, in turn, is controlled by Carter F. Bales, Craig B. Klosk, Matthew E. Gormly, III, Daniel M. Kortick, Jamie M. Weston and Daniel L. Black. This control structure was approved by the Media Bureau acting under delegated authority, on April 6, 2005. See FCC File Nos. BALH-20050110ABD/E/F.

Assuming the prior consent of the Media Bureau, upon consummation of the proposed pro forma transfer of control of the licensee, Wilks License Company-Fresno LLC will continue to be controlled by Wilks Broadcast-Fresno LLC which, in turn, is controlled by Wilks Broadcast Group LLC which, in turn, is controlled by Wilks Broadcast Group Holdings LLC which, in turn, *will be controlled by Wilks Broadcast Group II Holdings LLC* which, in turn, will be controlled Wicks Radio Group LLC which, in turn, is controlled by Wicks Communications & Media Partners III, L.P., which, in turn, is controlled by its sole general partner, Wicks Capital Management III, L.P. which, in turn, is controlled by its sole general partner, Wicks Apex III, Inc. which, in turn, is controlled by Carter F. Bales, Craig B. Klosk, Matthew E. Gormly, III, Daniel M. Kortick, Jamie M. Weston and Daniel L. Black. This control structure was approved by the Media Bureau acting under delegated authority, on April 6, 2005. See FCC File Nos. BALH-20050110ABD/E/F. The language in italics identifies the legal entity which is being inserted into the ownership chain of the licensee.

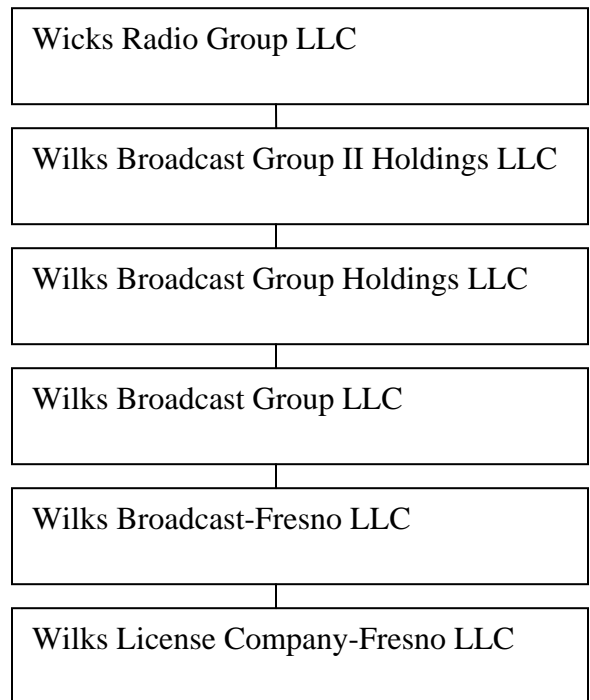
The instant application is one of five being filed contemporaneously herewith to effectuate minor corporate restructuring of Wicks Radio Group LLC in order to facilitate a new station acquisition.

No asset purchase or similar agreement is executed in connection with this reorganization. The transaction described herein will be memorialized in internal corporate documents such as memoranda between the affected companies and meeting minutes, as well as in state corporate filings necessary to effectuate the transactions. These documents are not provided herein, as they are mechanical in nature, or not yet in existence.

<sup>2</sup> Wilks Broadcast Manager LLC is intended to provide a vehicle by which principal executive officers of Wilks Broadcast Group LLC and managers of the various station clusters would be able to participate in “upside” value through (i) “promote” interests granted in connection with the performance of services and (ii) “investment” interests issued in exchange for capital contributions. The percentage participation of this entity, as of the date hereof in Wilks Broadcast Group Holdings LLC and in the future (after giving effect to the exchange of member interests referred to in note 1 above) in Wilks Broadcast Group II Holdings LLC, as well as the identity and participation levels of the members of this LLC, in each case attributable to promote interests, will be determined in the future, but could under certain circumstances be in the aggregate up to a maximum of 25% (subject to time-based vesting, possible forfeiture and performance criteria), after return to the investors in Wilks Broadcast Group II Holdings LLC (that is, after giving effect to such exchange of member interests) of all invested capital plus a preferred return thereon (corresponding to Class A Member LLC interests in Wilks Broadcast Group II Holdings LLC).

<sup>3</sup> The persons granted or to be granted membership interests in Wilks Broadcast Manager LLC have made or will be expected to make capital contributions to this entity in exchange for “investment” interests therein.
