** K. James Yager, Chris Cornelius, Keith Bland and Mary Flodin also are officers and members of Barrington Broadcasting Company, LLC ("BBC"), a Delaware limited liability company, which entity, following consummation of the instant transaction, will provide management services to KRCG, Jefferson City, Missouri. (BBC provides similar services to the three TV stations currently owned by affiliates of Assignee (see Exhibit 13).) BBC is a member of Barrington Broadcasting LLC ("Barrington LLC"), the immediate parent of Assignee (see Section II of this exhibit), but it does not presently hold any actual membership interests and does not possess any voting rights or rights to appoint officers or directors of Barrington LLC. BBC has only a contingent interest in Barrington LLC in the form of distribution of net cash from the sale of capital assets when certain thresholds are met. Nevertheless, the instant application provides the information regarding BBC that would be called for if a party to the application in the event its interest were deemed attributable. Neither BBC nor its officers and owners have attributable media interests other than in the three television stations identified in Exhibit 13.

*** As set forth in the most recent Pilot Group GP LLC ("Pilot GP") ownership report (BOS-20040701ADN), the minority membership interests of three inactive members — Lerer Investments LLC (3.6%), Martin L. Edelman (0.8%) and Marshall Cohen (0.4%) — are considered nonattributable by the applicant. None participate in the management of Pilot GP (except when approvals for certain extraordinary company actions are required), and none are involved in the day-to-day operations of Pilot GP. None has other attributable media interests.

**** As set forth in the most recent Katonah Pittman Ventures LLC ("Katonah LLC") ownership report (BOS-20040701ADY), the membership interests in Katonah LLC of the Robert W. Pittman Children's Trust ("Pittman Trust") and of Katonah Pittman Ventures, Inc. ("KPVI") are considered nonattributable by the applicant. Robert W. Pittman ("Mr. Pittman"), Managing Member of Katonah LLC, created the Pittman Trust for estate planning purposes with his wife and his financial advisor (Robyn S. Transport) as trustees, and he owns 100% of KPVI. Currently, Mr. Pittman holds 51% of the Class A interests of Katonah LLC directly with his Pittman Trust holding 48% and his company KPRV holding 1%. Mr. Pittman holds 99% of the Class B interests and his company KPVI holds the remaining 1% interest. The management of the business and affairs of Katonah LLC is entrusted to Managing Member Mr. Pittman who makes the decisions for the company, and the allocation of interests among the Class A and Class B members of the company reflect certain estate-planning strategies for his heirs. Neither the Pittman Trust nor KPVI participates in the management or day-to-day operations of the company. Neither has other attributable media interests.
