**NATURE OF THE PROPOSAL**

*Beacon Broadcasting, Inc.* (“*Beacon*”) is the licensee of WEXC(FM), Ch. 296A in Greenville, PA. WEXC is licensed to operate with an effective radiated power (“ERP”) of 3 kW at an antenna height above average terrain (“HAAT”) of 73 meters with a directional antenna. *Beacon* is presently operating WEXC under Special Temporary Authority (BSTA-20020826ABT) with an ERP of 1.1 kW at an antenna HAAT of 96 meters with a directional antenna. Under the instant proposal WEXC will operate with an ERP of 3 kW and an antenna HAAT of 100 meters at a different site than the licensed site.

The proposed site is an existing tower structure registered with the Commission; the registration number is 1013110. The proposed antenna system will be side-mounted on the tower structure. No change in overall structure height is proposed.

The principal community of Greenville is encompassed by the proposed WEXC 70 dBμ coverage contour. The attached **Exhibit 24 - Figure 1** supplies a coverage contour map for the proposed WEXC facility.

The proposed WEXC facility meets all of the minimum distance separation requirements of §73.207 of the Rules with respect to all other pertinent stations and allotments as contained in the Commission’s CDBS database, with the exception of the licensed Class B facility of WRQK-FM, Canton, OH. WRQK-FM began operation prior to November 16, 1964 and the separation distances required by §73.207 at that time WEXC has remained “short spaced” to WRQK-FM since. However, subsequent changes in the Commission’s separation tables (MM Docket 88-375) cause WEXC to become “short-spaced” to WRQK-FM. The licensed WEXC did meet the minimum distance separation requirements established §73.213(c)(1) and will continue to do so from the proposed new location. The proposed WEXC facility is 3 kW at 100 m, and conforms to §73.213(c)(1). An allocations spacing summary table is provided as **Exhibit 24 - Table 1**.

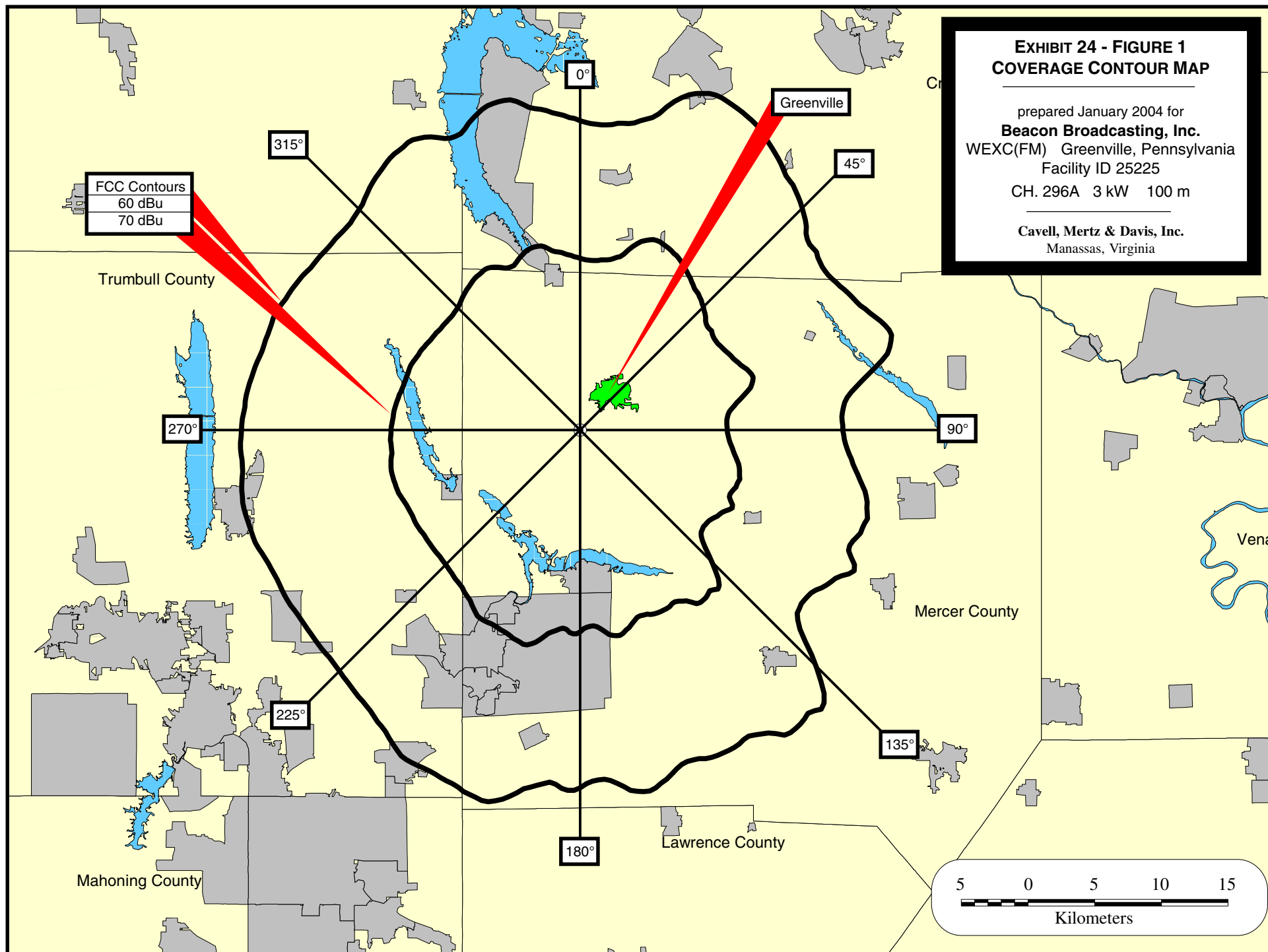
