This Mutual Consent Agreement (the "Agreement") is made as of November 12, 2007 by and between American Educational Broadcasting, Inc. ("AEB") and Educational Media Foundation ("EMF").

WHEREAS, EMF and AEB desire to jointly consent to mutual contingent minor changes to the facilities of their stations, KZAI(FM), Coolidge, Arizona, and KAIC(FM), Tucson, Arizona, both licensed to EMF

and AEB is the permittee of KLKA(FM), Globe, Arizona.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged by the parties, and upon the mutual promises and covenants made herein, the parties hereto agree as follows:

1. EMF hereby agrees to request a (i) minor modification of its KZAI(FM) licensed facilities to reduce the effective radiated power ("ERP") to .001kW(H)/8kW(V) and (ii) a minor modification of its KAIC(FM) licensed facilities to change the channel and community

of license from Tucson, Arizona to Mammoth, Arizona contingent upon AEB's agreement to modify KLKA's facilities to change the channel, move to a new tower site and change the community of license from Globe, Arizona to Casa Grande, Arizona.

2. AEB hereby agrees to request a minor modification of its KLKA(FM) facilities to change the channel, move to a new tower site and change the community of license from Globe, Arizona

to Casa Grande, Arizona contingent upon EMF's agreement to modify its KZAI(FM) licensed facilities to reduce the ERP to .001kW(H)/8kW(V) and modify its KAIC(FM) licensed facilities to change the channel and community of license from Tucson, Arizona to Mammoth, Arizona.

3. The parties hereby agree to coordinate and concurrently file with the FCC applications to modify the facilities of their respective stations as described in this Agreement. The parties

agree that, other than the exchange of promises set forth in this

Agreement, no other consideration shall be paid or exchanged between the

parties.

4. EMF and AEB agree that no change in

facilities shall be effectuated by either party unless and until the FCC

has granted both parties' applications for their respective above

mentioned changes.
