Dear Dan:

This office is communications counsel to Radio Ranch, Ltd., the licensee of FM Station KRNH(FM), Kerrville, Texas, which broadcasts its programming on FM Channel 221.

We are writing to you in your capacity as communications counsel to Iglesia Jesucristo es Mi Refugio, Inc., the licensee of FM Translator Station K221EX, Lackland City, Texas, and pursuant to Section 74.1203 of the Rules and Regulations of the Federal Communications Commission.

As you are aware, Section 74.1203 provides that the licensee of an FM translator is not permitted to operate if it causes actual interference to an authorized broadcast station. Since K221EX commenced operations on Channel 221, earlier this year, KRNH has suffered interference from K221EX's operations. Such interference is evidenced by the communications and complaints that KRNH has received from its regular listeners, a number of which are attached hereto.

Under the terms of Section 74.1203, K221EX is required to remediate the interference it causes to authorized stations such as KRNH and, if that is not possible, to suspend its broadcast operations until it can effectuate such remediation. Our client advises us that K221EX has recently suspended its broadcasting operations, though we have no reason to believe that such suspension relates to KRNH. We, therefore, request that before K221EX resumes broadcasting operations that it ensures that no further interference is caused to KRNH. Should this not be the case, we will have to bring this matter to the attention of the FCC for remedial action.

Should you client wish to coordinate with KRNH on testing to confirm its remedial actions, we





I hope this letter finds you well. I am writing to express my disappointment in the broadcast signal of your radio station, The Ranch, KRNH. For several years, I have been able to listen to the station to learn of the "goings on" in the Hill Country. You will recall that I own property in nearby Marble Falls.



In the last few weeks, starting the week of February 23rd, my ability to tune in The Ranch on 92.3 has been compromised due to interference from another station broadcasting in the Spanish language. I don't speak Spanish and can't recognize the station's call sign. I usually pick The Ranch up in my car in the Leon Springs area and on some days I am able to listen all the way to my office in San Antonio.

Please correct your signal so that I may continue listening.






