

**DTV INTERFERENCE CONSENT AGREEMENT**

Maine Public Broadcasting Corporation dba Maine Public Broadcasting Network ("MPBN"), as licensee of noncommercial educational Station WCBB(TV/DT), Augusta, Maine, and MPBN, as licensee of noncommercial educational Stations WMEB(TV/DT), Orono, Maine, and WMED(TV/DT), Calais, Maine, hereby enters this DTV INTERFERENCE CONSENT AGREEMENT ("Agreement") on this 20th day of June, 2008.

WHEREAS, MPBN has applied for and been granted a construction permit to operate WCBB-DT post-transition on channel 10 at an ERP of 13.32 kW in FCC file number BPEDT-20080317ACC;

WHEREAS MPBN seeks now to apply for maximized post-transition facilities for WCBB-DT on channel 10 at an ERP of 30 kW;

WHEREAS, MPBN's operation of WCBB-DT at an ERP of 30 kW would cause new interference in excess of 0.5% to stations WMEB-DT and WMED-DT; and

WHEREAS, MPBN as licensee of WMEB-DT and WMED-DT is willing to consent to such new interference;

NOW, THEREFORE, in consideration of the foregoing, MPBN, for WCBB-DT, and MPBN, for WMEB-DT and WMED-DT, hereby agrees as follows:

1. MPBN, on behalf of WMEB-DT, Channel 9, and WMED-DT, Channel 10, will accept interference from the proposed digital television facilities of WCBB-DT, Channel 10, operating at 30 kW as specified in an application to be filed with the FCC by June 20, 2008.
2. MPBN certifies that WMEB-DT and WMED-DT will be able to serve their communities of license, despite the new interference from WCBB-DT.


3. MPBN agrees that the proposed power of 30 kW for WCBB-DT will permit improved service to the public, and therefore is in the public interest.

4. Except for the foregoing, this Agreement imposes no other obligation on either party, including any obligation on the part of Station WCBB(TV/DT), WMEB(TV/DT), or WMED(TV/DT) to take any action to resolve any interference that may be caused or received by any Station to or from WCBB-DT.


5. This Agreement shall run with the licenses for WCBB(TV/DT), WMEB(TV/DT), and WMED(TV/DT). It shall automatically be assigned to, and be binding on, any and all successor licensees of WCBB(TV/DT), WMEB(TV/DT), and WMED(TV/DT).
