

**DESCRIPTION OF THE TRANSACTION  
AND CHANGES IN INTEREST**

**I. DESCRIPTION OF *PRO FORMA* TRANSFER OF CONTROL**

The instant application seeks consent of the Federal Communications Commission (“Commission”) to the *pro forma* transfer of control of WKBW-TV License, Inc., licensee of WKBW-TV, Buffalo, New York (“Licensee”). On December 11, 2006, Granite Broadcasting Corporation (“Granite”), Licensee’s ultimate parent, submitted a voluntary petition (“Petition”) for bankruptcy to the United States Bankruptcy Court for the Southern District of New York (“Bankruptcy Court”) seeking to reorganize under Chapter 11 of the U.S. Bankruptcy Code. *See In re Granite Broadcasting Corporation, et al.*, Case Number 06-12984 (Chapter 11) (Bankr. D. NY).<sup>1</sup> The Petition, a copy of which is attached hereto, seeks bankruptcy protection for Granite. Attachments 1 and 2 to this Exhibit depict Licensee’s ownership structure before and after the *pro forma* transfer of control for which FCC consent is sought herein.

The proposed *pro forma* transfer of control does not effect a substantial change in the control of Licensee, as the officers, directors, and shareholders of Licensee remain unchanged following the filing of the Petition. Moreover, Mr. W. Don Cornwell continues to control Licensee and Granite, Debtor-in-Possession, subject to the jurisdiction and oversight of the Bankruptcy Court. Accordingly, use of FCC Form 316 is appropriate for the described transaction.

Similar applications are being filed simultaneously herewith for the following commercial television stations ultimately controlled by Granite:<sup>2</sup>

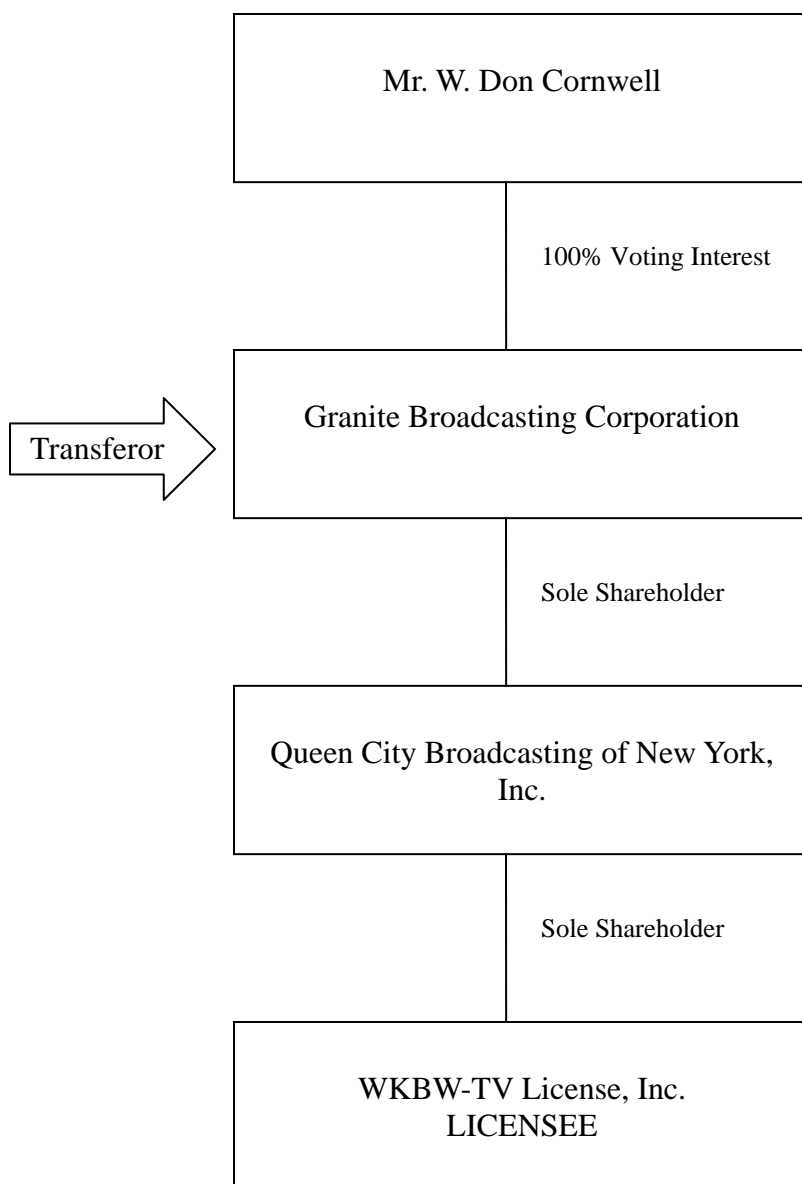
