ENGINEERING STATEMENT

This engineering exhibit is being submitted by TU-MAR BROADCASTING of Houghton, Michigan and is in support of their application to move the transmitter sites of WHKB-FM and WOLV-FM to the WCCY-AM site. TU-MAR is the owner of all three facilities. The FCC has already issued a construction permit for the move of WHKB-FM.

In November of 1997 an LMA study was conducted by DATAWORLD, INC. at the request of TU-MAR. This study showed that no FCC rule was violated by the mutual ownership of these three stations. Since the requested move of transmitter sites involves such a small amount, it is hoped that the same study will show no violations.

Station WHKB-FM will move 3.5 km to the north while WOLV-FM wishes to move 2 km to the south-southwest. In addition to the data from the original study, we are including a map showing the contours as they existed in 1997 along with a map showing the site move and the new call letters.

The construction permit that was issued to WHKB (formerly WAAH) to increase the ERP to 36 kw has expired and there are no plans to request its reinstatement.


