Purpose of Amendment

This application is amended to reflect the following: (1) Cumulus Media Inc. (“CMI”) and certain affiliates of Blackstone FC Communications Partners L.P. (“Blackstone,” and, with CMI, collectively, the “Transferees”) have joined and signed the application as parties thereto, and (2) Cumulus Media Partners, LLC (“CMP”) has caused its licensee subsidiary (the “Licensee”) to join and sign the instant application as a party thereto and to certify that, subject to and concurrently with the consummation of the transfer of control proposed in this application, (a) Thomas H. Lee Equity Fund V, L.P. and certain of its affiliates (“THLee”) and Bain Capital (SQ) VIII, L.P. and certain of its affiliates (“Bain”) (collectively, the “Transferors”) will become non-attributable members of CMP pursuant to amendments to the organizational documents of CMP which, *inter alia*, incorporate the Commission’s criteria for insulated members of limited liability companies and (b) CMP has no actual knowledge that THLee or Bain will be materially involved in the management or operation of CMP after their membership interests become non-attributable. This amendment does not change the identity of the Transferors or Transferees or the interests to be held as a result of the proposed transfer. The specific changes are set forth below:

Section I is amended to update the Licensee’s contact information.

Section II is amended to provide a revised Exhibit 4B and a revised Exhibit 5 (discussed below).

Section III is amended to reflect that the Licensee has signed the Licensee certification to the application as a party thereto. The response to Section III, Question 3, has been changed from “yes” to “no” and an explanation has been provided in Exhibit 6.

Section IV is amended to reflect that the Transferees have signed the Transferees’ certification to the application as parties thereto and have provided their respective contact information. Contact information also has been provided for the representatives of both Transferees. The response to Section IV, Question 5, is being changed from “yes” to “no.” The response to Section IV, Question 8(a), is being changed from “yes” to “no.”

Attachment 1 to the application (Letter of CMP counsel) has been deleted in its entirety now that the Transferees and the Licensee have joined and executed the application as parties thereto.

Exhibit 4B (“Request for ‘Permit-But-Disclose’ Status”) is replaced by a revised Exhibit 4B. Although contained within the Transferors’ portion of this application, the revised Exhibit 4B reflects that the Licensee and Transferees join the Transferors in requesting permit-but-disclose status under the FCC’s *ex parte* rules.

Exhibit 5 (“Description of Transaction”), including the attachments thereto, is replaced by a revised Exhibit 5 reflecting that THLee and Bain will, subject to the Commission’s consent requested in this application, become non-attributable members in CMP pursuant to

amendments to the organizational documents of CMP which, *inter alia*, incorporate the Commission's insulation criteria.

Exhibit 6 ("Explanation of Licensee/Transferee Certifications") is deleted as no longer necessary. The parties are submitting a copy of the Amendment, dated as of November 20, 2007, by and among CMP, CMP Susquehanna Holdings Corp., CMI, Bain, THLee, and Blackstone (excluding Annex B thereto).

Exhibit 7 ("Other Media Interests") is replaced by a revised Exhibit 7 to provide updated information concerning the other media interests of CMP and the Licensee.

Exhibit 11 ("Contact Information of Transferees") is amended to provide contact information for the Transferees.

Exhibit 12 ("Nature of Applicant"). A new Exhibit 12 has been submitted with this amendment to provide information regarding the jurisdictional formation of each Transferee.

Exhibit 14 ("Transferees") is replaced by a revised Exhibit 14 that provides updated ownership information for the Transferees.

Exhibit 16 ("Other Authorizations"). A new Exhibit 16 has been submitted with this amendment to provide updated information regarding the other media interests of CMP and the Transferees.

Exhibit 17 ("Attributable Agreements") has been deleted in its entirety because it is not necessary.

Exhibit 18 ("Multiple Ownership") is replaced by a revised Exhibit 18 that provides updated multiple ownership information.
