TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Amigo Radio LP (“Amigo”), proposed assignee of radio stations KTNZ, 1010 kHz, and KBZD, Channel 259C3, Amarillo, Texas. Principals of Amigo also have attributable interests in the licensee of KQFX, Channel 282C1, Borger, Texas, and have a Time Brokerage Agreement with the licensee of KZIP, 1310 kHz, Amarillo, Texas.¹ The 3.16 mV/m contours of KBZD and KQFX overlap. The 5.0 mV/m contours of KTNZ and KZIP also overlap. Further, the contours of the two FM stations overlap with the contours of the two AM stations. This results in Amigo having common interests in two FM stations and two AM stations in the same market. Exhibit #1 is a map depicting the stations.

2. Therefore, a study has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. The study will determine the number of other commercial AM and FM stations that either have transmitter sites within, or provide coverage to, the subject Radio Market. Since the contours of KQFX and KZIP encompass the contours of both KTNZ and KBZD, they establish the Radio Market boundary for this instant study.

1) Amigo is also the licensee of KGRW, Channel 234C2, Friona, Texas. The 3.16 mV/m contour of KGRW and the pending minor change application for the station do not overlap with either KBZD or KQFX. As such, it is shown on Exhibit #1, but is not considered in this instant analysis.

3. Exhibit #2 is a depiction of the stations in the Radio Market, showing seventeen commercial AM and FM stations, including the four subject stations. Exhibit #3 is a tabulation of the stations in the Radio Market. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.² At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Amigo's interests in two FM stations and two AM stations in the same market are in compliance with the Commission's rules. Therefore, Amigo's proposed ownership of KTNZ and KBZD is in compliance with §73.3555 of the rules.

2) Although there are additional stations providing service to the Radio Market, they are not considered since the number of stations was ample to demonstrate compliance with the rules based on the number of stations proposed to be commonly owned.








