

## AMENDMENT

This Amendment (“Amendment”) to the Assignment by and among Sinclair Television Group, Inc., Traverse City (WGTU/WGTQ), Inc. and Traverse City (WGTU/WGTQ) Licensee, Inc., LLC, and Barrington Broadcasting LLC and the other Barrington Parties (as defined in the Assignment), dated March 15, 2013 (the “Assignment”), is dated as of April 18, 2013.

### Recitals

WHEREAS, the parties have agreed to amend certain provisions, exhibits and schedules of the Assignment.

NOW THEREFORE, in consideration of the agreements made herein and for other consideration deemed sufficient by the parties and intended to be legally bound, the parties hereby agree to amend the Assignment as follows:

1. Section 1.2 shall be stricken in its entirety and be replaced with the following:

At the closing under the Agreement, Assignee shall pay Assignor (or its designee) for the Station Assets the aggregate amount of \$2,500,000, such payment made as directed by Assignor.

2. Exhibit A of the Assignment shall be stricken in its entirety and be replaced with Attachment 1 hereto.

3. Section 2.3(a) of the Asset Purchase Agreement (Exhibit to Exhibit C of the Assignment – Option Agreement) shall be stricken in its entirety and replaced with the following:

(a) The aggregate purchase price for the Assets shall be equal to the sum of Two Million Five Hundred Thousand Dollars (\$2,500,000) (the “**Purchase Price**”). The Purchase Price shall be adjusted as provided for in Section 2.3(c) of this Agreement.

4. Except as amended by this Amendment, the Assignment, and the exhibits and schedules thereto, shall remain in full force and effect, enforceable in accordance with their respective terms.

5. The Barrington Parties are executing this Amendment for the limited purpose of satisfying the requirements of Section 9 of the Assignment relating to amendments. The execution of this Amendment by the Barrington Parties shall not modify the scope of the limited purposes for which the Barrington Parties are party to the Assignment or expand their obligations or representations thereunder.

6. This Amendment may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all such counterparts




