Parties to the Application

Bonten Media Group LLC (“Bonten Media Group”), proposed transferee of BlueStone TV Holdings Inc. (and its licensee subsidiaries), is a newly-formed Delaware limited liability company.¹ Two of Transferee’s three LLC members — Diamond Castle Partners IV, L.P. and Bonten/Diamond Castle, LLC — are controlled, directly or indirectly, by DCP IV GP, L.P. Diamond Castle Partners IV, L.P. has the right to designate at least a majority of the members of the governing Management Committee of Bonten Media Group. As a result, Diamond Castle Partners IV, L.P., through its general partner DCP IV GP, L.P., holds the power to exercise control of the Transferee.
