**INFORMAL OBJECTION**

Danny Ray Boyer, ("Petitioner") hereby files this Informal Objection ("Objection") to the above captioned application by Saver Media, Inc. ("Saver") for minor modification to an original construction permit for KQTC (FM) at Eldorado, TX (the "Modification Application") which seeks to modify the technical parameters of the original construction permit granted to the current permittee's principal (and prior permittee) Tony Cuellar ("Cuellar") by, inter alia, changing the coordinates of the transmitter site.

**Standing**

Petitioner has standing pursuant to Section 73.3587 to file informal objections to the Saver application, which is an application for an instrument of authorization.

**Background**

KQTC was originally permitted by BNPH-20120529ALB, granted February 20, 2013, at which time FCC staff dismissed this Petitioner's Petition to Deny that application, finding that

Cuellar was qualified to be a Commission licensee, despite irregularities in the original construction permit application regarding Cuellar's prior criminal convictions. Subsequent to the February 20, 2013 grant of the original construction permit, Cuellar filed an application to assign the now granted construction permit on February 28, 2013 to Saver Media, Inc., a Texas corporation (BAPH-20130228AKP, amended March 4, 2013) which was granted on April 10, 2013 and consummated on April 12, 2013 according to the Commission's records, to Saver Media, Inc. Thereafter the instant application to modify the technical parameters of the original construction permit was filed by the current permittee, Saver Media, Inc.

### **Objections**

Petitioner's objections to the instant application are as follows:

1. Saver, by and through its principal, Cuellar, has misrepresented facts to the Commission in its prior applications. For example, in the Form 316 referenced above, filed on February 28, 2013 and amended on March 4, 2013, Cuellar represented that he was assigning the original construction permit to "Saver Media, Inc.", a Texas corporation owned by Cuellar and his wife (see, e.g. Exhibit 12 to the Assignment Application). However, a search of the Texas Department of State records reveal that there is no such entity organized in Texas as a corporation with that name (see attached Exhibit "1"), and that the only similar entity is a "Saver Media, LLC" which appears to be a limited liability company organized by Mr. Cuellar on **August 12, 2013** (and filed on August 14, 2013)(Exhibit "2) a full 4 months AFTER Cuellar consummated the assignment of the construction permit to the non-entity known as Saver Media, Inc.

2. Cuellar, in the original construction permit application for KQTC, specified a transmitter site and 135.8 meter AGL tower at 31 degrees 1 minute 5 seconds North, 100 degrees

35 minutes 43 seconds West (NAD 27) with ASR Registration #1286554. Cuellar made those representations presumably upon the “reasonable assurance” of site availability required by the Commission’s Rules. However, as evidenced by the attached Declaration of Barbara West Clark (Exhibit “3”) the owner of the real property at those coordinates, no such assurance was ever granted to any party nor was permission ever given to even go onto the property for the purpose of ascertaining its availability for a tower site or to apply for permission to construct a facility on her property.

Despite the foregoing, Cuellar, both individually and on behalf of Saver Media, Inc., (which does not exist) has repeatedly certified to the Commission in his applications that “the statements in this application are true, complete, and correct to the best of my knowledge and belief, and are made in good faith. I acknowledge that all certifications and attached Exhibits are considered material representations”


It would seem to be readily apparent, given the foregoing circumstances, (together with Cuellar’s failure to disclose his prior felony conviction to the FCC before the issue was raised by this Petitioner in the original construction permit application), that at a bare minimum the fitness of Cuellar/Saver Media, Inc. to be an FCC permittee should be examined in the context of the FCC’s Character Qualifications, 102 FCC 2<sup>nd</sup> 1179 (1985) reconsideration denied, 1 FCC Rcd 421 (1986), as modified 5 FCC Rcd 3252 (1990) and 7 FCC Rcd 6564 (1992).

### **Conclusion**

For the foregoing reasons demonstrating a propensity to misrepresent material facts to the Commission, and because the purported applicant entity does not even legally exist, Petitioner states that it would not serve the public interest, convenience and necessity to grant the instant application for modification of the KQTC construction permit at Eldorado, TX and requests that the Commission designate the aforementioned application for public hearing for further inquiry

regarding the issues raised herein.


