That we, the undersigned, have this day voluntarily associated
ourselves for the purpose of forming a non-profit corporation pursuant to
Nevada Revised Statutes 81.290 through 81.340, inclusive, and

WE DO HEREBY CERTIFY THAT:

FIRST: The name of this corporation shall be LIBERTY BAPTIST
CHURCH OF LAS VEGAS.

SECOND: The corporation will be a non-profit corporation organized
solely for educational, religious and charitable purposes.

THIRD: The principal place of business of the corporation will be
in Clark County, Nevada.

FOURTH: The number of trustees shall not be less than three, but
the number of trustees may be increased by a majority vote of the membership
at an annual or special business meeting. Each trustee shall serve for a term
of one year, or until his successor has been duly elected and has accepted
office.





NINTH: Upon the winding up and dissolution of this corporation

after paying or adequately providing for the debts and obligations of the
no. 2386-78 corporation, the remaining assets shall be distributed to another

independent fundamental Bible-believing Baptist church or to the Baptist
Bible Fellowship International whose headquarters are located at 2157 N.
Prospect, P.O. Box 191, Springfield, Missouri 65801, which is organized
and operated exclusively for charitable, educational or religious purposes
and which has established itself tax exempt status under Section 501(c)(3)
of the Internal Revenue Code.

TENTH: No part of the net earnings of this corporation shall
ever inure to or for the benefit of or be distributable to its members,
trustees, officers or other private persons, except that the corporation
shall be empowered to pay reasonable compensation for services rendered
and to make payments and distributions in furtherance of the exempt purposes
for which it was formed.

ELEVENTH: Notwithstanding any other provisions of these articles,
the corporation shall not carry on any other activities not permitted to be
carried on by a corporation exempt from Federal income tax under Section
501(c)(3) of the Internal Revenue Code of 1954.

The above amendment was approved by a majority vote of the congregation
on the 23rd day of December, 1984.

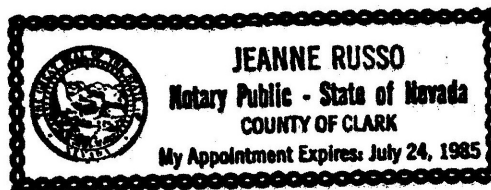


