

COMMUNITY BROADCASTERS, LLC

Community Broadcasters, LLC (“Community Broadcasters”) is a New York limited liability company. Community Broadcasters is a Board of Managers controlled LLC, “with full and complete discretion in the management and control of the business and affairs” of the Community Broadcasters. Accordingly, the Board of Managers of Community Broadcasters controls Community Broadcasters.

The following persons comprise Community Broadcasters’ Board of Managers, each of whom has a single vote on the Board:

As noted below, there are five limited liability members of Community Broadcasters. Each is represented on the Board. Mr. Leven represents himself. Mr. Mittman represents himself. Northwood Ventures LLC (“Northwood Ventures”) and Northwood Capital Partners LLC (“Northwood Capital”), which have the right to appoint three persons to Community Broadcasters’ Board of Managers under the terms of the Community Broadcasters Operating Agreement, have appointed Peter G. Schiff, Paul Homer and Henry T. Wilson to the Board.

Peter G. Schiff is the sole Managing LLC Member of Northwood Ventures and of Northwood Capital. Since Mr. Schiff controls Northwood Ventures and Northwood Capital, and those two entities, in turn, control three of the five votes on the Board of Managers, Mr. Schiff holds *de facto* control of Community Broadcasters.

Provided below are the voting and equity percentages of the LLC Members of Community Broadcasters:

¹ The voting interests set forth in the table above are included for FCC purposes and are consistent with the fact that as between Northwood Ventures and Northwood Capital, they have the right to appoint three of five (60%) of the Members of the Board of Managers and that each of Messrs. Leven and Mittman has essentially appointed himself as a Member (20% each) of the Board of Managers.

For sake of completeness, it should be noted that the four LLC Members also have Class B "voting interests" ("Class B Voting Interests") for purposes of making certain "major action" decisions for Community Broadcasters. Those "Class B Voting Interests" are as follows: Northwood Ventures LLC (69.214%); Northwood Capital Partners LLC (12.214%); James L. Leven (15.476%); Bruce J. Mittman (3.095%). The Class B Voting Interests only come into play in those circumstances where the Board of Managers must present to the Class B Unit Holders certain “major action” matters for decision by such voting unit holders, *e.g.*, a proposal to issue additional Class A Units or Class B Units, a proposal to sell the stations, and other “major action” matters. None of that diminishes the fact that Community Broadcasters is a Board of Managers controlled legal entity. In any event, Mr. Schiff controls the Board of Managers via his control of the appointment of three of the five Board members, as well as the “major action” process through Northwood Venture LLC which holds a majority of the Class B unit votes.

All parties to the application are either U.S. citizens or U.S. limited liability companies. Peter Schiff is the Manager and President of Northwood Ventures and Northwood Capital; Henry T. Wilson is a Manager and Managing Director of Northwood Ventures and Northwood Capital and Paul Homer is the Vice President of Northwood Ventures and Northwood Capital. All other LLC Members of Northwood Ventures and of Northwood Capital are fully insulated under the rules and regulations of the FCC. No party to the application has any other attributable broadcast interests other than through Community Broadcasters' Time Brokerage Agreement with the radio stations which are the subject of this application.
