KRRE 91.9MHz +/- 600KHz contours

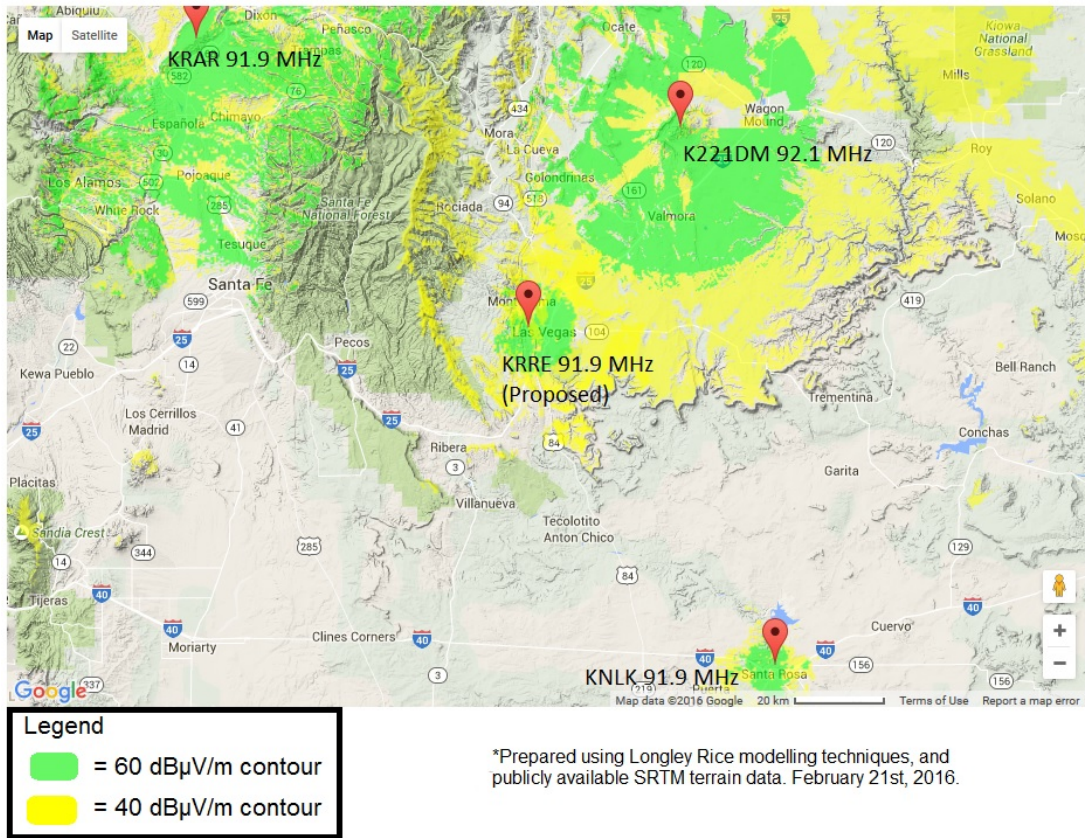
